**If more than three, kindly summarize** (200 words limit): Both as an expert and as the President of the Greek National Commission for Human Rights, I make regular statements to the press, am invited for interviews and appear on the media mostly to comment on current events, ranging from COVID-19 measures to violence against women to Roma inclusion. A significant proportion relate to migration issues, including the presentation of the Greek National Report on Migrants at Borders, part of an ENNHRI project (15 July 2021); the launch event on the OHCHR-UNOCT trainers guide on human rights at international borders (25 October 2021); or the rebuttal to the Greek Minister for Migration during the 18th Annual Lecture of the LSE Hellenic Observatory (22 June 2021). Under my leadership, the Greek National Commission for Human Rights has also made its first recorded public statement, the day the leaders of Golden Dawn, the neonazi organization, were found guilty of a number of criminal offences, including murder. I am also invited to public discussions and webinars on the human rights aspects of climate change, as I participated in the drafting committee for a climate law offered by WWF Greece to the Greek Government: the bill is currently on public consultation and will be presented to Parliament by the end of the year.

My academic background has the advantage of a flexible schedule, as I may organize my classes and assorted lectures relatively freely within the parameters of the academic year: my current schedule allows for a term of intensive teaching engagements to be followed by a term of research and thus I am well in a position to dedicate the required amount of time to the mandate. As an international law scholar, I travel quite frequently (even during these times of the pandemic) and I am also well-tuned to the exigencies of long-distance communication and the digital world. Belonging to an international community of scholars, I am quite adept at working in the field, public speaking and relating to persons and countries the world over, including addressing stressful situations in conditions of crisis. The discipline of academic research and the targeted effort required offer an excellent training field for the intensive work required by the mandate.

I am an independent candidate – as befits both my academic background and my position as the elected head of a National Human Rights Institution, with the status of an independent authority. I am also particularly pleased and grateful for the letters of support offered by the Global Alliance of National Human Rights Institutions – GANHRI and two major environmental non-governmental organisations: Greenpeace Greece and WWF Greece.

### **III. MOTIVATION LETTER, INCLUDING YOUR VISION OF THE MANDATE**

In my latest book on 'Energy at Sea', I explore the transition to renewable sources of energy as evidence of an emerging human right to climate stability, with the ancillary rights of access to the best available science and the preservation and protection of an environmental acquis while in the ILA Committee on sea-level rise I explore the impact of climate change on legal norms. In a major funded research project with a team of brilliant young researchers, we challenge the fundamental tenets of the field, exploring the limits of the concept of sovereignty and its impact on universal concerns, including climate change. I had long argued in my scholarship that we need to build upon the architecture of human rights protection. essentially thinking of new, out-of-the box ways in which we could use our venerable tools with a view to adjusting to emerging needs and making full use of the experience and expertise gained from a robust system of protection: the recent spate of climate-related cases brought before the UN treaty bodies and human rights adjudication both before international and domestic courts speaks to the advantages of that incremental approach, which takes full advantage of our existing toolbox – and as such is duly noted in the Glasgow Climate Pact. Indeed, as head of an NHRI and member of the Board of the European Network of National Human Rights Institutions (ENNHRI), I have consented to an intervention before the European Court of Human Rights in the Seniors case.

On the other hand, there is no doubt that the piece-meal approach of human-rights-based climate litigation does not fully cover the essentially distributive nature of climate justice. It is the reason I have been involved, along with an excellent team of outstanding legal scholars, in developing a Global Pact on the Environment. And I am thrilled that the Human Rights Council recognised in resolution 48/13 the human right to a clean, healthy and sustainable environment and called upon States to cooperate to implement this right.

The greatest challenge of a scholar, however, lies in translating theory to practice and declarations of intent to functional, effective and sustainable policies. I was pleased and honoured to have been invited by WWF Greece to participate in the drafting of the first climate law for the country: harnessing expectations to viable policies and effective legal tools is often an exercise in frustration but the combination of outstanding expertise and positive political will have made this effort particularly rewarding: the draft has been accepted by the Government and a climate bill is currently in public consultation soon to be discussed in Parliament.

This is but an example of the efforts required to address the challenges of the climate crisis. As a GANHRI Bureau member, I encouraged the creation of a GANHRI Caucus to strengthen the link between human rights, climate change and climate justice mostly in the Global South, and have the Greek NCHR participate in an exchange of knowledge, experiences and good practices among NHRIs across all regions of the world with a view to addressing the climate crisis with a human-rights based approach, working towards a just transition to a zero-carbon economy with the benefits and burden of climate action shared equally through decisions that are participatory, non-discriminatory and accountable and ensure access to effective remedies. This is the manner in which I view the present mandate: a ground-breaking challenge which is at the same time an excellent opportunity for effective contributions to current thinking on the climate crisis, building on adaptation, mitigation and resilience and common action. Coming from a collegial institution, which serves as a bridge between the State and civil society, I have long experience in accommodating often widely conflicting interests and opinions and

seeking a common ground which is viable and effective and certainly not the lowest common denominator. In fact, that could be my compass: joint action for a common future.
