Relevant educational qualifications or equivalent professional experience in the field of human rights; good communication skills (i.e. orally and in writing) in one of the six official languages of the United Nations (i.e. Arabic, Chinese, English, French, Russian, Spanish.)

I have worked independently as an international attorney in Afghanistan for over 13 years and am the first foreigner to litigate cases in its courts as well as in the informal jirgas. I am known for my work in human rights and women's rights. In this regard, I have worked on complex issues with all parties who have competing interests in very delicate situations. I have worked alongside civil society and am routinely called upon to provide legal analysis and advice in the areas of women's rights, business matters, human rights, issues involving minority populations, etc. Having worked with civil society in Afghanistan for over a decade, including traditional society in the form of local jirgas, I am uniquely positioned to properly evaluate and offer recommendations in human rights and women's rights issues.

I have also conducted and published research regarding human rights and women's rights issues in Afghanistan. I traveled throughout Afghanistan and collected data from hundreds of incarcerated persons, judges, lawyers, etc. and observed numerous courts and jirgas throughout the country. With this insight, I was able to track crime typology, sentencing disparities, etc. Evaluating this information gave me a unique perspective and ability to develop concrete recommendations. My legal and research experience has given me nuanced expertise in human rights issues in Afghanistan.

For over 13 years, I have worked as an international human rights attorney and have successfully defended the rights of many marginalized groups, women, and persons in Afghanistan's courts including for a number of high-profile cases. This experience has allowed me to use Afghan Laws, international human rights instruments, and women's rights laws such as the Elimination of Violence Against Women Act (EVAW) in my litigation practice.

Since 2009 I have pioneered supporting women's rights in Afghanistan, including aiding the first prosecution of police for failing to do their job in protecting women who are victims of violence. One such case involved an Afghan woman who was raped and charged with adultery and running away. I represented the woman pro bono and advocated for her release from prison based on a presidential pardon, and her release was granted. In addition to her release, the Afghan president decriminalized running away as a crime. This case helped to

validate the women's rights unit within the AG's office which allowed women who were victims of crimes to report such abuse in the hopes of prosecution of the abusers. I have also routinely utilized the EAW law and successfully represented female victims in court.

By being able to use international human rights instruments in Afghanistan courts this offered me a unique lens into how the policies and international laws work in practice.

3. ESTABLISHED COMPETENCE (200 words limit)

I have been internationally recognized as an expert in human rights and women's rights in Afghanistan. In this capacity, I am an author and have had numerous publications about human rights, women's rights, and juvenile justice in Afghanistan. In addition, I am routinely called upon as an expert to speak about human rights issues in relation to Afghanistan, and have testified as an expert in courts in the U.S., Belgium, the U.K., Australia, etc. My expertise in Afghanistan for on the ground fact finding initiatives allowed me the unique ability to develop conclusions and offer substantive recommendations some of which were incorporated within the Afghan legal system. I have the benefit of not just being an interlocutor for human rights but have seen how these decisions work in real time.

I am licensed to practice law in the ICC for defense & victims, the International Residual Mechanism for Criminal Tribunals, the UAE DIF Courts, and have permission to practice in Afghanistan since 2009. I am also licensed in the U.S. Supreme Court, the U.S. Court of International Trade, the U.S. Appellate Courts 2nd, 4th, 7th, 9th, & 10th Circuit, the District Court of Colorado, and all U.S. Districts in Oklahoma and Wisconsin. I am also a trial monitor for the ABA & the Clooney Foundation.

I am passionate about working within the human rights sphere in Afghanistan and have done so for over thirteen years. I possess the skills that a successful candidate for this position should have which is deep on the ground experience in human rights. My expertise and experience is such that I have a unique ability to develop conclusions and recommendations that would be very specific to the challenging environment in Afghanistan.

I chose to work independently within the legal system on human rights issues for the last 13 years in Afghanistan. This allowed me to do so without the backing or encumbrances of any institutions to work objectively and competently in getting a deep understanding of human rights issues. Working independently has also given me a high level of credibility in regards to my work on human rights. I have been involved in a high range of human rights issues that has created a strong trusted network in women's rights, business, and human rights. I have deeply sourced trusted networks and an intimate on the ground knowledge of the human rights issues throughout Afghanistan.

Given the dire humanitarian situation in Afghanistan it is important that the person chosen can hit the ground running and start working immediately. In order to be effective for this role, the candidate should have substantial on the ground experience and institutional knowledge of Afghanistan's human rights issues before the Taliban take-over in order to also provide a comparative analysis to the present situation on the ground. The person should have experience as I have in knowing how to develop effective research strategies in order to properly evaluate the human rights situation throughout Afghanistan.

I have traveled throughout the country and am well-resourced to connect with civil society and experts on the ground in person or remotely. This insight has given me the precision to understanding the nuances of Afghan culture in the varying provinces as it relates to human rights issues. The research and recommendations that I gave on juvenile justice issues was used in part by UNICEF to create certain rule of law programs.

There have been many disturbing reports of current women's rights and human rights violations. I have the capacity and the expertise to immediately engage my deep networks entrenched throughout Afghanistan as this mandate is massively context specific and requires a deeply nuanced complex approach in order to understand the human rights environment. I have worked with all sides of a situation including engaging with groups that traditionally have not allowed women a voice, let alone a leading one. In this area my long experience in Afghanistan will help to bring you views from all parties in the human rights sphere. I have conducted research and presented written reports reflective of my deep background in Afghanistan and will be able to deliver a report that can give the UN a true reflection of the human rights situation.

I also routinely integrated gender perspectives and a survivor-centered approach throughout my work in Afghanistan. While living and working in Afghanistan in order to achieve justice for my clients, I have worked with all sides of a situation including engaging with groups that traditionally have not allowed women a voice. My long experience in Afghanistan will help to bring you views from all parties in the human rights sphere
