Following my work in national politics (USA), I served as a diplomat in the Second, Third, and Fifth Committees for two U.N. Member States (2008-2011). In these capacities, I served as chief elections officer (Maldives) and spearheaded various initiatives focused on human rights issues, humanitarian affairs, and climate change concerns. III. MOTIVATION LETTER, INCLUDING YOUR VISION OF THE MANDATE

Freedom of thought, conscience, and religion or belief (FoRB) is core to the human pursuit of truth and the presence of meaning in life. Protection of this right facilitates this pursuit and reinforces myriad other human rights, including, but not limited to, freedom of expression, freedom of association, and the right to non-discrimination. More broadly, the need to protect FoRB also highlights the need to safeguard civic spaces and promote equality in today's diverse and ever-changing societies.

Despite the wide-ranging and complex nature of the challenges facing the promotion and protection of this freedom, FoRB remains predominantly overlooked and marginalized from broader action on human rights. Given the interrelated and interdependent nature of human rights, poor attention to FoRB leads to protection gaps for several other relevant rights and can present hurdles to promoting other national and international imperatives. Consequently, the protection of FoRB requires a multifaceted, multistakeholder approach that is firmly grounded in the international human rights framework.

I am a seasoned advocate with a background in international relations and over 20-years of experience working for and with national governments, intergovernmental organizations, and civil society actors to advance universal human rights law and standards. For the past twelve years, I have provided technical support to the work of two U.N. special procedures, including the HRC's mandates on freedom of religion or belief and on the situation of human rights in the Islamic Republic of Iran. My contributions (including through legal research, extensive fact-finding, and fieldwork) to the publication of twenty-six Special Procedure reports illustrate my grasp of the requisite knowledge for carrying out the work of this mandate.

Specifically, and most pertinent to my application is my work to support efforts to address poorly understood issues related to FoRB and identify practical solutions in cases where FoRB appears to conflict with other rights or where there are competing claims for the protection of FoRB. My engagement with concerns about Islamophobia/anti-Muslim hatred, freedom of thought, anti-Semitism, the securitization of FoRB, and the rights of persons belonging to religious or belief minorities in situations of conflict or insecurity are central to this work. My work also demanded a rigorous examination of the sobering and ubiquitous circumstances where FoRB intersects with other rights concerns. This includes where the exercise of FoRB engages the enjoyment of freedom of expression, association, and assembly and where the right is misused to perpetuate gender-based discrimination and violence.

My professional experiences have intimately acquainted me with the critical need for diplomatic, strategic, and balanced approaches to advancing the duties tasked by the Council to any mandate-holder. This is significant given the need for mandate holders to be impartial, independent, and objective while carrying out tremendous responsibilities with limited resources. To this end, I have spent the better half of my professional career working with a concert of actors to mitigate the impact of inadequate resources on the effectiveness of U.N. special procedure work.

Of paramount importance and meaning to me in my career has been my involvement in bridging the work of international monitoring and accountability mechanisms with that of local actors and institutions. This work has involved contextualizing international human rights law

and standards for diverse constituencies in numerous countries, enhancing the capacity of advocates to engage U.N. mechanisms, and taking a survivor-centered approach to monitoring and documentation. Working in consultation with rights-holders and affected communities would be fundamental to my working methods in fact-finding and advising the Council. I believe in a bottom-up approach to determining the strategies and practices that most effectively realize global human rights norms for all persons.
