
# WHY ARE WE HOLDING THIS EVENT?

- We want adults and children to know that children have a right to be protected from being sold and from being sexually abused..
- Our world is constantly changing, with more adults and children spending time online, more people on the move, and the COVID-19 pandemic disrupting our daily lives. These changes can make it easier for people to sell or sexually abuse children, and harder for children to protect themselves from these crimes...
- By signing the Optional Protocol, 177 countries around the world have agreed to take specific steps to prevent this abuse and keep children safe.
- The UN Committee on the Rights of the Child wants to hear the views of children and adults on how governments can protect children from being sold or from being sexually abused.

#### DID YOU KNOW ?

- That countries must ask children for their views on how to better prevent the sale and abuse of children and how to protect victims?
- That countries must find out which children are particularly at risk of becoming victims to such crimes and take specific steps to protect them such as protecting their identity and informing them on their rights?



• That investing in children and protecting their right to be free from violence helps countries achieve the <u>Sustainable Development Goals?</u>

#### THE SPEAKERS WILL ANSWER QUESTIONS SUCH AS:

- · How are children being informed about their rights to be protected from sale and sexual abuse? In school, books and brochures, TV, radio, the internet, social media, theatre, animated films? Is this information reaching the children who are most at risk and hard to reach?
- · Are these materials effective in empowering children to stop these crimes and to also help parents and carers to prevent, identify and appropriately respond to the abuse and to report offenders?
- Do children have a space where they have the opportunity to make their voices heard on the issue, including in children's clubs, youth groups, associations, student councils, youth forums, children's parliaments and blogs?
- · Are adults asking children for their views on how to improve programmes that are designed to protect children and on how to make recommendations for policy improvements, and to identify issues and areas that might lead to risks of abuse, as well as on ways to protect themselves from abuse?
- · Are children treated fairly by the police, lawyers, and judges in criminal cases against offenders?

# WHAT ARE CHILDREN'S RIGHTS ?

· Children's rights are the human rights of anyone under 18: they help to make sure all children are treated fairly and looked after properly, so that every child can grow up in a happy, healthy, fair and safe environment. Children's rights include the right to go to school, the right to share their views, the right to live without violence, and many others. They are listed in the UN Convention on the Rights of the Child (UNCRC). Read the articles and get to know your rights here
