Questionnaire

The following questionnaire aims to assist Member States, civil society and other relevant actors in providing information and inputs for the above-mentioned report. For the purposes of this questionnaire, "children and youth" refers to persons 29 years old and under.¹

- 1. Please identify the ways that diversion² of arms³ and unregulated or illicit arms transfers impact on the enjoyment of human rights by children and youth. Please elaborate on the nature and extent of such impact. Are there rights that are particularly affected? (e.g. right to life, freedom of movement, education, health, etc.)
- 2. How do the diversion of arms and unregulated or illicit arms transfers contribute to the commission of the six grave violations against children during armed conflict namely the recruitment and use of children, killing or maiming of children, sexual violence against children, abduction of children; attacks against schools or hospitals; denial of humanitarian access for children⁴.
- 3. If your State undertakes and/or authorises arms transfers, please highlight any good practices and lessons learned you are aware of or challenges you have faced in preventing, mitigating and addressing the diversion of arms.
- 4. If your State undertakes and/or authorises arms transfers, has it established a national control system or equivalent? If so, how does it prevent, mitigate and address the diversion of arms and unregulated or illicit arms transfers that have a particular impact on the enjoyment of human rights by children and youth? What considerations, including national procedures and/or laws and international norms and standards, does the control system take into account when making export assessments? On what information and from what sources of information does it base its assessments?
- 5. If your State undertakes or authorises arms transfers, has your State in the past refused to proceed with or authorise an arms transfer due to the risk that those arms could be diverted? What considerations, including national procedures and/or laws and international norms and standards, did your State take into account in undertaking any risk assessments and or in refusing authorisation of the transfer? Did your State take specific measures to assess the impact of possible diversion on the
