The Trust Fund has supported 32 governmental officials including 23 women, of the 14 members of the CARICOM. None of our members have been left behind since they have been supported at least once.

The Trust Fund activities and continuous engagement has made a difference in our region.

I highly commend, and urge all, to support our Trust Fund, an exceptional Champion for LDCs/SIDS participation in the HRC.
