YOUTH ADVISORY BOARD

In partnership with Education Above All and Silatech, the Office of the United Nations High Commissioner for Human Rights established a Youth Advisory Board in February 2022. Selected from a pool of 166 applicants following an open call, the Youth Advisory Board was set up in order to provide feedback and input on the overall direction of the project 'Working with and for youth in vulnerable situations including conflict, violence, and insecurity'. The Youth Advisory Board consists of ten young people from different countries and regions.
