

INDEPENDENT EXPERT ON DEBT, OTHER INTERNATIONAL FINANCIAL OBLIGATIONS AND HUMAN RIGHTS*

The Independent Expert is one of the Special Procedures mechanisms of the Human Rights Council.

Mandate holders:

- undertake country visits
- act on individual cases of reported violations and concerns of a broader nature by sending communications to States and others
- contribute to the development of international human rights standards,
- engage in advocacy, raise public awareness,
- provide advice for technical cooperation.

THE INDEPENDENT EXPERT IS EXPECTED TO EXAMINE:

- The effect of foreign debt on all human rights particularly in developing countries.
- The social impact of the measures arising from foreign debt.
- The impact of illicit financial flows on the enjoyment of human rights.
- Other international financial obligations and their impact on human rights.

TERMS OF THE MANDATE

According to resolution 49/15, the Independent Expert is requested to pay especial attention to:

(a) The effects of foreign debt and the policies adopted to address them on the full enjoyment of all human rights, in particular economic, social and cultural rights;

(b) The impact of foreign debt and other related international financial obligations on the capacity of States to design and implement their policies and programmes, including national budgets that respond to vital requirements for the promotion of the realization of social rights;

(c) Measures taken by Governments, the private sector and international financial institutions to alleviate such effects in developing countries, especially the poorest and heavily indebted countries; (d) New developments in actions and initiatives being taken by international financial institutions, other UN bodies and intergovernmental and nongovernmental organizations with respect to economic reform policies and human rights;

(e) The effects of public debt, economic reform and financial consolidation policies on the realization of the SDGs;

(f) The impact of illicit financial flows (IFF) on the enjoyment of human rights;

(g) Follow-up to the International Conference on Financing for Development.


COUNTRY VISITS

COMMUNICATIONS

Communications are letters based on information received on human rights violations and send to States, and non-State actors, for clarification and action.

Since January 2010, the mandate has sent over 90 communications (letters of allegation, urgent appeals or others letters, under the special procedures communication procedure).

These communications have been addressed to States, international financial institutions (i.e. IMF and the World Bank), banks and other stakeholders.
