What is the EDVAW Platform?

- ▶ The Platform of Independent Expert Mechanisms on Discrimination and Violence against Women (EDVAW Platform) is a Platform for thematic and strategic collaboration between independent UN and regional expert groups on violence and discrimination against women.
- ▶ It aims at improving the implementation of existing international and regional legal and policy frameworks by creating synergies and amplifying the recommendations of the different mechanisms to combat discrimination and violence against women and promote accountability.

What does the EDVAW Platform do?

- ▶ The Platform hosts and engages in a series of consultations, information exchanges, and follow-up discussions around common concerns of global relevance and thematic areas of priority in different regions hosted through the regional mechanisms, with the participation of civil society and other stakeholders.
- ▶ The Platform also develops joint positions, in the form of joint statements, enhances information sharing and intends to intensify its outreach through communication tools and materials.
