Human rights defenders are persons, who individually, or in association with others, work peacefully to promote and protect universally recognized human rights and fundamental freedoms, in accordance with the UN Declaration on Human Rights Defenders.

Defenders around the world peacefully promoting and defending human rights operate under national legal frameworks not always fully consistent with the United Nations Charter and international human rights law. In some instances, as echoed in multiple Human Rights Council and General Assembly resolutions. In national legislation, in particular national security and counter-terrorism laws, or regulations on civil society and public freedoms have been misused to target defenders in a manner contrary to international law, that might result in long-term arbitrary deprivation of liberty.

- 5) What actions do you suggest the Special Rapporteur can take to:
 - a) Prevent defenders from being detained for long terms in connection to their human rights work? And

Take as quick actions as possible with concerned authorities when HRDs are arrested, before charges are pressed (it is typically more difficult to get HRDs released once a case has been brought against them).

Publish statements, op-eds and other public material to raise the awareness of the general public on the issue of arbitrary detention of HRDs. Such public positions could be published jointly with other Special Procedures (e.g. UN Special Rapporteur on the right to freedom of expression, UN Working Group on Arbitrary Detention – UNWGAD, etc.), as well as regional HRD-protection mandate-holders (ACHPR Special Rapporteur on the situation of HRDs, IACHR Rapporteur on the situation of HRDs, etc.).

Organise webinars, and consider local visits (sanitary situation allowing), to interact with local HRDs in order to exchange on the issue of long-term arbitrary detention of HRDs, express public support with those arbitrarily detained, and publicly call for their release.

b) Have those human rights defenders arbitrarily detained under long sentences released?

Call for the release of arbitrarily detained HRDs as part of regular engagement with UN member-States.

Cooperate with the UNWGAD to follow-up on cases of arbitrarily detained HRDs, relay UNWGAD decisions on HRDs through public statements, and follow-up with concerned UN member-States.

Cooperate with the UN Special Rapporteur on counter-terrorism and human rights, especially as many HRDs detained for more than 10 years were initially sentenced under terrorism charges.

Engage with UN Treaty Body experts to raise their awareness about long-term arbitrary detention of HRDs, and formulate recommendations ahead of UN member-States reports' examination.

Stress the issue of long-term arbitrary detention of HRDs and formulate recommendations as part of pre-UPR briefings.
