The Secretary-General of the United Nations has the honour to refer to the provisions of article 17, para. 6 of the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, which read as follows:

"If a member of the Committee dies or resigns or for any other cause can no longer perform his Committee duties, the State Party which nominated him shall appoint another expert from among its nationals to serve for the remainder of his term, subject to the approval of the majority of the States Parties. The approval shall be considered given unless half or more of the States Parties respond negatively within six weeks after having been informed by the Secretary-General of the United Nations of the proposed appointment".

In this connection, the Secretary-General would like to inform His Excellency's Government that, following the resignation of Ms. Honghong Zhang, a national from China and member of the Committee against Torture, the Government of China has decided to appoint Mr. Liu Huawen to carry out the Committee's duties entrusted to Ms. Zhang until the expiry of the latter's mandate, i.e. on 31 December 2021. Attached is a biographical note in concerning Mr. Huawen transmitted by the Government of China. This note is available in Chinese and English only.

In accordance with provisions of article 17, para. 6 of the Convention, the appointment of Mr. Huawen as member of the Committee shall be considered approved unless half or more of the States Parties respond negatively within six weeks from the date of this note, i.e. by **10 February 2020**.
