She led the Half-day of General Discussion on Girls and Women with Disabilities. She co-chairs the working group in charge of drafting the General Comment on Women with Disabilities (Article 6). She acted as Spanish Government's delegate for the drafting of the Convention on the Rights of Persons with Disabilities, focusing on mainstreaming gender issues in crosscutting and specific manner through Article 6.
- Spokesperson as expert on gender issues in the Council of the Royal Board on Disability, the Women's Health Observatory of the Ministry of Health and Consumer Affairs, the State Observatory against Gender Violence and the Governing Board of the Spanish Women's Institute.
- She is a Member of the Board of the European Women's Lobby (2010-14) and has been participating as civil society representative in the Commission on the Status of Women (New York) since 2010.
