seventh session, that the Committee adopted a Concept Note offering an overview of

the legal context and the thematic areas to inform the elaboration of the General

Recommendation.

During the more than 30 years of CEDAW's history, the different components of girls' and women's right to education – as enshrined in article 10 of the Convention – have been recurrent issues of concern in our constructive dialogues with States parties, in our Concluding Observations as well as in other General Recommendations.

The lack of comprehensive coverage of the right to education for girls and women underscores the need for this General Recommendation, which will be instrumental in providing guidance to States parties as to the implementation of their obligations to respect, protect and fulfil the right to education of women and girls under article 10 of the CEDAW Convention.

In conclusion, I would like to invite all speakers and interveners to observe the time limitations for their interventions. Unfortunately, it will not be possible to accommodate all requests for interventions, as their number exceeds the time available. We will therefore need to cut off the oral statements at 12:30 a.m. to allow for questions and answers.
