Formulates and manages the implementation and monitoring of appropriate government policies and development master plan for Indigenous Peoples (IPs); Assists the Congress of the Philippines in the legislation of laws addressing the rights and general welfare of the IPs; Maintenance of a research center and management information system; Ensures policy coordination and provides assistance to ensure respect of the rights of IPs in the Autonomous Region in Muslim Mindanao.

Main professional activities:

Advocates the recognition, protection and promotion of the rights of IPs; Reviews and assesses their conditions including existing laws and policies pertinent thereto and to propose relevant laws and policies to address their role in national unity and development; Co-facilitates the delineation and titling of ancestral domains/lands and ensures the rights of IPs thereto; Coordinates with government agencies, the private sector and international bodies development programs and projects for the advancement of IPs and to oversee the proper implementation thereof; Facilitates the formulation of ancestral domain sustainable development and protection plans as blue-print for development of ancestral domains; Co-facilitates the issuance of appropriate certification as a pre-condition to the grant of permit, lease, grant, or any other similar authority for the disposition, utilization, management and appropriation by any private individual, corporate entity or any government agency, corporation or subdivision thereof on any part or portion of the ancestral domain taking into consideration the consensus approval of the IPs concerned; And, to represent the IPs in international conferences and other related concerns.

Educational background:

It should be noted that membership in the Committee on the Elimination of Racial Discrimination requires participation in two annual sessions (February/March and August) of three weeks duration.

He was an honor student at the elementary and secondary levels and graduating as magna cum laude in College. He was a recipient of leadership awards to include the boy scout and YMCA leadership awards and the Gerry Roxas Leadership Award for talented and deserving Filipino student leaders. He graduated the degree of Bachelor of Arts in English and completed the academic requirements for Master in Public Administration. He was a grantee of the Chevening Scholarship on human rights studies by the British Government but deferred in favour of community based practical learning situations.

He actively participated as then focal person of the National Commission on Indigenous Peoples to the Presidential Human Rights Committee. He headed the committee to monitor and report State compliance to the UN ICERD and co-drafted the 1<sup>st</sup> National Human Rights Action Plan of the Philippines. He managed the constitution of the Indigenous Peoples Consultative Body of the Philippines to unify and strengthen the leadership ranks of the Indigenous Peoples in asserting their equality of rights and fundamental freedoms. The consultative body strengthens the political empowerment of IPs at all levels. He also spearheaded the drafting of the national guidelines on the mandatory representation of Indigenous Peoples in local legislative councils and other policy-making bodies which is now being implemented to ensure that Indigenous Peoples actively engage and participate in governance. This further ensures that IP perspective shall be incorporated in local policy instruments and mechanisms. He currently engages in community organizing and advocacy to strengthen community assertion of both their collective and individual rights, especially in investment driven areas.
