## **Pledges**

1) In light of the commitments we have made under the Convention on the Rights of the Child and its Optional Protocols, as applicable, we have undertaken the following to highlight our commitment to the promotion, protection and realization of the rights of the child in celebration of the 30th anniversary of the Convention:

- The Government of Albania recognizes that residential institutional care provision does not offer children the best opportunity to grow and develop. A renewed policy is being prepared with the aim of advancing gradual and full De-Institutionalization of children from all residential care facilities, through re-enforcement of family support and alternative care options.

How? - Recognizing De-Institutionalization as a priority, the government has prepared a multi-year draft DI Action Plan, which is in line with country's broader development plans and strategies, in particular the Social Inclusion Policy 2016-2020, the national Strategy for Social Protection 2015-2020 and the National Agenda for Children's Rights 2017-2020. The deinstitutionalisation strategy aims to establish an integrated, functional and inclusive system focusing on the family and, on the best interests of the child, creating functional inter-institutional mechanisms and establishing efficient financial instruments.
- A multi-disciplinary assessment of over 240 children residing in nine public residential care institutions. As a result, each assessed child now has a development and reintegration plan. The next step will consist in implementing all individual plans, transforming public residential care institutions into family support centres and strengthening foster care alternatives for children.

A big event will be organized in Korca, a model city towards child-friendly policies. The event will be child-led, with the participation of more than 300 children from the regions around and suburbs as well, including children from vulnerable groups such as children from Roma/Egyptian communities, children with disabilities and children in street situations. The event will be organized in cooperation with partners and civil society organisations working for children's rights. The key message will be: every child has the right to childhood. Children will be at the centre of the event, and we will avoid speeches from authority, but rather invite decision-makers and adults to listen to children's voices.
