By way of background, it is recalled that pursuant to Human Rights Council resolution 6/10 of 28 September 2007 the Advisory Committee has been requested "to prepare a draft declaration on human rights education and training" and, to this end, seek the views and inputs from all relevant stakeholders on the possible elements of the content of the declaration, taking into account existing relevant instruments.

In implementing Council resolution 6/10, the Advisory Committee, at its first session (held from 4 to 15 August 2008), entrusted a five-member drafting group with the task of undertaking preparatory work for consideration by the Advisory Committee, with a view to submit further elements to the Advisory Committee at its second session, and also requested the Secretariat to disseminate the questionnaires addressed to the various stakeholders (see recommendation 1/1 of 14 August 2008). At its second session, the Advisory Committee adopted recommendation 2/1 on the same issue.
