Background:

In its resolution 11/4, the Human Rights Council reaffirmed that "the peoples of our planet have a sacred right to peace, and that the preservation of the right of peoples to peace and the promotion of its implementation constitute a fundamental obligation of all States" and stressed the importance of peace for the promotion and protection of all human rights for all.

In its resolution 14/3, the Council requested the Advisory Committee to work on a draft declaration on the right of peoples to peace, in consultation with Member States, civil society, academia and all relevant stakeholders. In January 2011, the Advisory Committee adopted a **progress report** (A/HRC/17/39), to be submitted to the 17th session of the Human Rights Council.
