Bangladesh

Mr. Md Rafiqul Alam Molla, a career diplomat, currently serving as Senior

Assistant Secretary of the Protocol Wing at the Ministry of Foreign Affairs since August 2016. He is responsible for taking care of state protocol issues which include the visits of the Hon'ble President and Hon'ble Prime Minister of Bangladesh to abroad. Besides, he also looks after the visits of foreign dignitaries to Bangladesh. Prior to his current assignment, Mr. Molla was engaged with versatile field of diplomacy at the Ministry of Foreign affairs. He dealt with Bangladesh's bilateral relations with East Asian and Pacific countries and multilateral engagements of Bangladesh with Organization of Islamic Cooperation (OIC), The Commonwealth, The Indian Ocean Rim Association (IORA), The Asia Cooperation Dialogue (ACD) and The D-8 Organization for Economic Cooperation (D-8) as desk officer. He joined in Bangladesh Foreign Service on January 2013. She keeps track of the work of various International Organizations Institutions Conferences such as the African Commission on Human and People's Rights, and the Human Rights Council, and advice accordingly. She also keeps track of international and regional human rights agreements and advice the Government on which to become party to and the legal implications thereto. She also participates in the preparation of human rights periodic reports to which Lesotho is a party to and negotiates bilateral and multilateral agreements, treaties on behalf of Lesotho Government to safeguard the Countries' interests. She is a deputy chairperson of the Inter-Sectoral Committee on Human Rights, an advocate of the High Court and Court of Appeal of Lesotho and a Chairperson of a Technical Committee on Diaspora Engagement. In connection with her State Party Reporting responsibilities, Ms. Lelisa benefited from the training organized by the UPR Branch of the Office of the High Commissioner for Human Rights, which was held in Entebbe, Uganda in 2018. She was engaged in the preparation of the Marshall Islands 2nd reporting of the UPR in 2014. Ms. De Brum was also part of the Marshall Islands team to Geneva in 2018 to present the report to CEDAW. Ms. de Brum holds a Master of Education (MEd) from Drury University, Missouri and a Bachelor of Science (BS) in Hospitality Leadership from the University of Southern Missouri, also in Missouri. He was part of the delegation of Timor-Leste which presented UPR report in 2016 and the CAT report in 2017. Mr. Flaviano holds a bachelor's in international Relations from the University of Muhhamadiyah Malang, Indonesia and a Master of Law from the University of Atma Jaya, Indonesia. In addition, she prepares Ratification Briefs on International Human Rights Conventions and legal opinions for the Attorney General on all matters relating to international law and human rights issues. Ms. Baggan holds a Bachelor of Laws (LL.B.) received with Honours and a Master of Laws (LL.M.) in Corporate and Commercial Law from the University of the West Indies. Additionally, she has received training in several workshops on Treaty Body Reporting and International Human Rights instruments such as the Convention on the Elimination of all forms of Discrimination Against Women (CEDAW), the Universal Periodic Review (UPR), the Convention on the Rights of Persons with Disabilities (CRPD) and the United Nations Convention Against Corruption (UNCAC).
