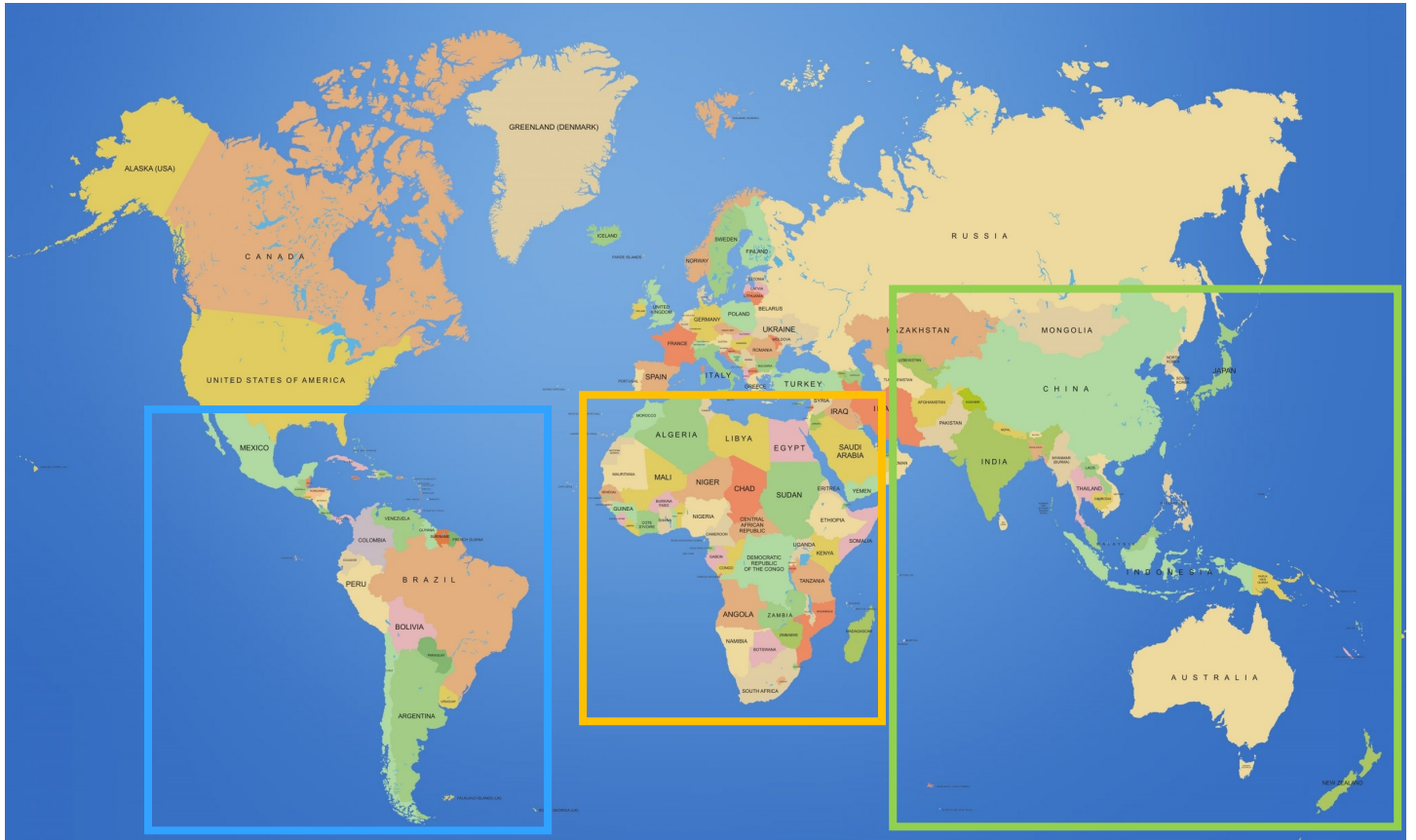

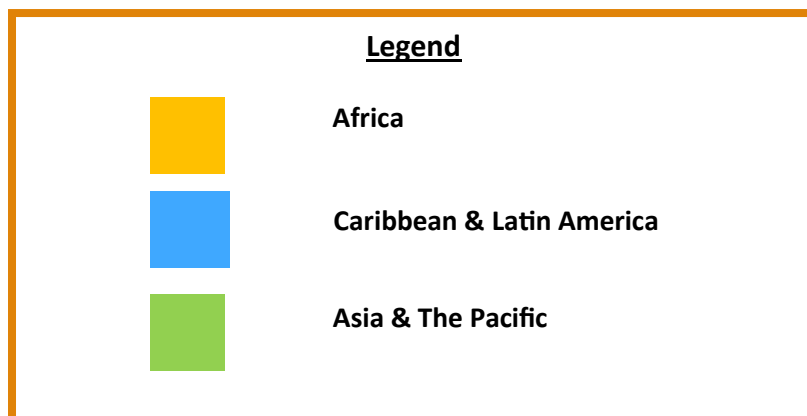

- ◆ Delivered a total of **36** statements: 34 in national capacity & 2 joint statements
- ◆ Participated in **9** briefings /side events organized by the Trust Fund with the support of Singapore, Australia, Pakistan, Office of the HRC President, the European Union and Universal Rights Group. *Four events were planned (with the Bahamas, Poland, CITI, Contact Group on HRC Membership) but had to be cancelled following the decision to suspend HRC3.*
