










Foreign Service Officer, Ministry of Foreign Affairs



Recalling the visit of the Special Rapporteur on safe drinking water and sanitation to Tuvalu in July 2012, a time when he was still in university, Efren recollects how that visit made a "lasting impression" on him. It was his introduction to the Council's Special Procedures system - the largest body of independent experts in the UN Human Rights system that address either specific country situations or thematic issues in all parts of the world. "The Rapporteur's visit really helped to sharpen the focus on this problem in a small island State like Tuvalu." Both he and Ricardo agreed that their experience in Geneva provided them with a greater understanding about Special Procedures, in particular the wide range of issues they cover.

Speaking about the Council's Universal Periodic Review, a system through which all UN member States are subjected to a human rights review every four years, Ricardo and Efren, both of whom have been charged with following up to their countries' reviews, noted the great potential this process has on achieving "real results". Yet they warned that recommendations need to be realistic and implementable. "A peer to peer review would work best when States really understand what other States are struggling with and what their challenges are," Efren remarked.

From 1994 to 1997, Ambassador Sherman-Peter was Assistant Director in the Political Affairs Division of the Commonwealth Secretariat in London, United Kingdom, and also served in various capacities in a broad range of regional and international meetings at levels including Heads of Government. She also served as Representative of the Bahamas on the United Nations bodies including the Commission on Narcotic Drugs from 1982 to 1994, the Economic and Social Council, the United Nations Commission on the Status of Women, as Chair of the United Nations Development Fund for Women (UNIFEM), and on various United Nations Expert Groups. She was Head and Consul General of the Bahamas Consulate General in New York from 1977 to 1988.

Mr. Seck was Minister Counselor, Director of International Organizations at the Ministry of Foreign Affairs from February to October 2012. He was also Minister Counselor, Director Africa Asia at the Ministry of Foreign Affairs from January 2011 to January 2012. Prior to that, Mr. Seck was Counselor at the Permanent Mission of Senegal to the United Nations in New York from November 2004 to December 2010 where he was in charge of political affairs, disarmament, peace and international security.

Between October 2001 and October 2004, Mr. Seck held the positions of Head of Africa Division and Africa -Asia Director at the Ministry of Foreign Affairs respectively. Mr. Seck has also been an instructor at the National School of Administration of Senegal from which he graduated summa cum laude (Diplomacy section) in September 2001. She provides support to the Ambassador on the financial and human resources management of the Mission. She was an expert on terrorism, advised on matters pertaining to Peace and Security in West Africa and was the facilitator and lead negotiator for Security Council outcomes (Resolution, Presidential statement, press statement related to West Africa). She was the Senegal expert in charge of the Sixth Committee of the United Nations General Assembly. Under her tenure, Mr. Sidiki KABA, current Minister of Armed Forces who was, at the time, the Minister of Justice, Keeper of the Seals, was elected as the first African President of the Assembly of States Parties to the Rome Statute of the International Criminal Court. She coordinated the Senegalese candidature as a non-permanent member of the Security Council for the January 1st, 2016 to December 31st, 2017 period for which Senegal got the best score with 187 votes out of 191 member States present and voting. She has held several other positions in Senegal embassies abroad and within the Ministry of Foreign Affairs. Ms. Fatou Gaye holds a Bachelor in International Law, a Master in Political Sciences and a Post-graduate degree in Diplomacy.
