ADOPTION OF THE AGENDA AND ORGANIZATION OF WORK

Status of preparation of documentation

Note by the Secretariat

- 1. The annexes to the present note provide information on the status of documentation before the Human Rights Council at its fourth session, as at 9 March 2007.
- 2. Pursuant to Council's decisions adopted at its regular and special sessions held in 2006, the preparation of 190 documents (including main documents and addenda thereto) has been envisaged for the fourth session of the Human Rights Council, amounting to 4050 pages. Also, as at 9 March 2007, 8 notes verbales and letters from Governments requiring circulation as documents of the Council have been received by the secretariat, and 144 written statements by non-governmental organizations have been submitted.
- 3. Some of the reports issued with a symbol number of the fourth session of the Council are scheduled for consideration at the fifth session. The full list of those reports is provided in paragraph 13 of the annotations to the provisional agenda for the fourth session (A/HRC/4/1/Add.1).
- 4. The Office of the United Nations High Commissioner for Human Rights (OHCHR) has done its best to respond to all the requests in the area of documentation and to give equal treatment to all legislative mandates. As already experienced in the past, due to the significant volume of documentation and late submission of some documents, the secretariat of the Council was again obliged to circulate some reports and addenda in one, two or three languages only, while some other documents are being issued in the original language(s) of submission with their summaries translated into all official languages.
- 5. In handling documentation issues, OHCHR is guided by the immediate priority of ensuring the availability of all documents scheduled for consideration at the present session in accordance with Council's programme of work.
