Information note on the Third session of the open-ended working group on transnational corporations and other business enterprises with respect to human rights, 23-27 October 2017, Room XX, Palais des Nations

The Office of the United Nations High Commissioner for Human Rights presents its compliments to all Permanent and Observers Missions to the United Nations Office at Geneva, specialized agencies, other intergovernmental organizations, national human rights institutions and non-governmental organizations and has the honour to inform them of the following:

- The third session of the working group will take place from 23 to 27 October 2017 in Room XX, Palais des Nations. The session will be held pursuant to Human Rights Council resolution 26/9, which decided that the Chairperson-Rapporteur "should prepare elements for the draft legally binding instrument for substantive negotiations at the commencement of the third session of the working group on the subject, taking into consideration the discussions held at its first two sessions".
- The elements for the draft legally binding instruments, the provisional agenda, and other relevant documentation of the session are on the website for the 3rd session, available at the following address:

- The Chairmanship of the OEIGWG welcomes written contributions received thus far in the process and invites all interested stakeholders to continue contributing to the preparation for the third session. Written contributions can be sent to the secretariat by e-mail (igwg-tncs@ohchr.org). In order for contributions to be published on the OEIGWG web page, it must be relevant to the OEIGWG session, contain no insulting or inappropriate language, and be submitted in one of the official UN languages. The email should include contact information for the representative submitting the statement (name, phone, email), the submitting organization's name (as it appears in the ECOSOC NGO database, if the organization has ECOSOC consultative status), the names of all other organizations joining the statement, and the title of the statement. All Submissions are final, and no changes can be made afterwards. Written contributions are posted, unedited, in the language(s) received from the submitting organization; OHCHR is not responsible for the content of any submission. Because OHCHR must verify that all of the above conditions are met, submissions received close in time to the third session may not be published on the web page prior to the start of the session.
- All UN Member and Observer States, specialized agencies and other international organizations, national human rights institutions with "A status" accreditation, and NGOs with ECOSOC consultative status may attend the public meetings of the working group. Please refer to the accreditation procedure on the above-mentioned page.
- All participants are encouraged to submit their statements in writing <u>prior</u> to their interventions to <u>igwg-tncs@ohchr.org</u> in order to facilitate simultaneous interpretation. All statements will be posted as received on OHCHR's website. If the

statement delivered is substantially different from the document initially received by the secretariat or if you do not wish the statement to be published online, please inform the secretariat. Kindly note that in line with the OHCHR disability policy, oral interventions made without written scripts cannot be shared on the website.
