*The State of Qatar is a party to five core human rights treaties:

- 1- Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment (CAT).
- 2- Convention on the Rights of the Child (CRC).
- 3- Convention on the Elimination of All Forms of Discrimination against Women (CEDAW).
- 4- Convention on the Elimination of All Forms of Racial Discrimination (CERD).
- 5- Convention on the Rights of Persons with Disabilities (CRPD).

*The State of Qatar is committed to submit its initial and periodic reports to the monitoring committees on time.

The State of Qatar accepted the simplified procedure adopted by the Committee against Torture (CAT), and submitted its third periodic report in accordance with it.

*In future, the simplified procedures of other monitoring bodies will be considered by the State, pursuant to the practical benefits of such reporting procedures and their efficiency.
