<u>Summary</u>

The Guiding Principles on Business and Human Rights for implementing the UN "Protect, Respect and Remedy" Framework are the first UN-endorsed framework to define the respective duties and responsibilities of Governments and business enterprises for preventing and addressing adverse human rights impacts arising from business activities. In its resolution 17/4, The Human Rights Council in 2011 unanimously endorsed the Guiding Principles and established the UN Working Group on Business and Human Rights with a mandate to promote the dissemination and comprehensive implementation of the Principles world-wide.

Contributing to strengthening and deepening dissemination of the Guiding Principles in all regions is a key strategic goal for the Working Group and core to its mandate. The Working Group considers that such efforts need to take into account the realities and needs of local contexts, in order to gain a better understanding of the challenges and opportunities for advancing towards effective implementation. Against this backdrop the Working Group decided to pursue organization of regional fora on business and human rights. The first such regional forum led by the Working Group was held for the Latin American and Caribbean region in August 2013.¹ Plans for an African regional forum in 2014 are currently being explored.

The Working Group also decided that a regional perspective on trends, implementation practices, challenges and opportunities should be one of the focus areas for the second annual Forum on Business and Human Rights.

With the support of the Governments of Argentina, Ghana, India, Norway and Russia, the Working Group is hosting a pre-Forum side event featuring discussions focused on each of the UN regions. These discussions will give stakeholders the opportunity to learn about key trends in the region and engage with the Working Group to discuss experiences of challenges, opportunities and lessons learned specific to the region.
