

### Trainings 2016

1. On 9–18 of February, 2016–the second phase of training was held by the Association of Social Workers for social workers, on the social work and child abuse issues (28 participants);
2. On 25–26 of February, 2016–the training was conducted by Public Health Fund for the Psychologists, on the topic: Supervision and Monitoring of the Child Abuse Cases, interviewing of a child, especially in cases of being the victim of violence/eyewitness, protection of the conclusion during the court hearing (11 participants);
3. On 22-23 of April, 2016– the training was held by the Human Rights Education Centre for social workers of Khobi and Senaki, on the topic: Physical, Psychological and Sexual Abuse against the Children (6 participants);
4. On 25<sup>th</sup> of May 2016, the organization- Public Health Foundation of Georgia conducted master class for the professionals working with the children, on the topic: “Complicated Behaviour of Children and Adolescents and the Peculiarities of Relationship with Them” (5 participants, 1 psychologist and 4 social workers);
5. On 24-28 of May 2016, State Fund for Protection and Assistance of Victims of Human Trafficking, held the training for the senior social workers, on the topic: “Reducing Domestic Violence in Georgia” (19 participants);
6. In the month of May 2016, LEPL State Fund for Protection and Assistance of Victims of Human Trafficking, held the training for the senior social workers, working within the framework of the sub-program for the homeless children, on the topic: “The Role of Social Work in the Field of Domestic Violence” (22 participants, TOT);
7. In November 2016, State Fund for Protection and Assistance of Victims of Human Trafficking, held the training for the senior social workers and the chief specialist of the administration for the children and domestic violence, on the topic: "Assistance Issues to Victims of Sexual Assault".
8. By the month of December 2016, State Fund for Protection and Assistance of Victims of Human Trafficking, held the training for the worker of the Social Service Agency, on the topic: „Reducing of Trafficking in Georgia”. (2 social workers).

### 2017

1. On 23–27 of January 2017– Public Health Foundation of Georgia and the organization -Child Welfare League, held the training in Tbilisi and East Georgia (Shida Kartli, Kvemo Kartli, Kakheti, Mtskheta-Mtianeti) for the senior social workers and the lawyers regarding the procedures of abstracting the child’s abuse and the issues related to the Juvenile Justice Code (23 participants), whereas in 6-10 February 2017, the same training was held in Batumi to the senior social workers and the lawyers of the West Georgia (Guria, Samegrelo-Zemo Svaneti, Imereti, Racha-Lechkhumi, Autonomous Republic of Adjara) (13 participants); All participants had passed the a training module for trainers, which gave them the opportunity to transfer and share the gained theoretical knowledge to the other staff of the Agency.
2. On 27<sup>th</sup> of March 2017 – the organization-Public Health Foundation of Georgia held the training for the Psychologists, on the topic: “Prevention of the Suicide of Children and Adolescents and Features of Crisis Intervention (13 participants);
3. On 24-26 of April 2017-the organization-Public Health Foundation of Georgia held the training for the social workers, psychologists and other child protection specialists (Eter Tskhakaia, Nino Tvildiani, Khatuna Jikia, Mari Tsereteli). The topic of the training was the following: Sexual abuse of a Child- Coordinated Response in Cases were the Child’s Sexual Abuse is Detected, Assessment of Cases, Planning of Intervention and their Implementation, Methods for Consultancy and Therapy, Relationship with the Parents of the Child-victim of sexual abuse, Cooperation with t Specialists of the Different Disciplines, Preparation of the Conclusion for the Court and Protection of the Child’s Interest. For the confirmation of the knowledge obtained on the training, bilingual certificates and

the book of Martin Niss: "Child as Victim of Violence, Positive Use of Violated Silence" were given to the participants of the training;

4. On 4<sup>th</sup> of May 2017, the organization- National Network for Protection Against Violence, held the training for the social workers of Tbilisi (11 participants) for the employees of the Ministry on Internal Affairs, on the topic: Coordination of the Police and Social Service Agency on Domestic Violence and Child Abuse facts (total number of the participants -21);

5. On 20<sup>th</sup> of May 2017- the training was held by the organization-National Network for Protection Against Violence, for the social workers of Mtskheta-Mtianeti Region (15 participants) and for employees of the Ministry on Internal Affairs, on the topic: Coordination of the Police and Social Service Agency on Domestic Violence and Child Abuse facts (total number of the participants -25);

6. 13. On 12<sup>th</sup> of October 2017, in collaboration with International Organization for Migration and by the financial support of INL, for the staff of LEPL Social service Agency, social workers, prosecutors and investigators a training was held in Batumi city on the topic: "Sexual Exploitation" (5 participants from the Agency),

14. On 28<sup>th</sup> of October 2017- the training was held by the organization-National Network for Protection Against Violence for the social workers of Tbilisi and for employees of the Ministry on Internal Affairs, on the topic: Coordination of the Police and Social Service Agency on Domestic Violence and Child Abuse Facts (total number of the participants -20);

15. On 30-31 of October and 1<sup>st</sup> of November 2017, within the framework of the project "Advocacy for Child and Youth Protection", which was supported by the EU, there was held a training by the Public Health Foundation of Georgia for the social workers, lawyers and psychologists of Tbilisi and on 6-8 November it was held in Zugdidi, on 18-20 of November- in Batumi, as well as for the

employees of Agency, on the topic: Victim Child of Domestic Violence and Sexual Abuse- Questioning, Detection, Response, Prevention (totally 50 participants);

16. Regional seminar organized by the Public Health Foundation of Georgia, was held on the issues of the International Program "Sexual Abuse against the Child" coordinated by the International Catholic Child Bureau (BICE);

17. On 21<sup>st</sup> of October 2017- the training was held by the organization- National Network for Protection Against Violence for the social workers of Imereti Region and for employees of the Ministry on Internal Affairs (15 participants) on the topic: Coordination of the Police and Social Service Agency on Domestic Violence and Child Abuse Facts (total number of the participants-30);

18. On 28<sup>th</sup> of October 2017-the training was held by the organization- National Network for Protection Against Violence for the social workers of Tbilisi (30 participants) and for employees of the Ministry on Internal Affairs, on the topic: Coordination of the Police and Social Service Agency on Domestic Violence and Child Abuse Facts (total number of the participants -50);

## **2018**

1. On 16-18 of February 2018– the organization -Initiative for Social Changes (ISC), held the training for social workers of Tbilisi, Mtskheta-Mtianeti and Samegrelo, Zemo Svaneti, on the topic: "Feminist Perspectives on Social Work" (6 participants);

2. On 23<sup>rd</sup> of March 2018 – the organization- Women's Initiatives Support Group held the training for social workers, on the topic: Increasing Awareness of the Rights and Specific Needs of LGBT Group Members (4 participants from Batumi and Zugdidi);

3. April 2018 - Georgian Association of Social Workers held the training of trainers for the social workers, on the topic: "Feminist Perspectives on Social Work" (6 participants);

4. On 15<sup>th</sup> of July 2018-the training was held by the Organization National Network for Protection Against Violence for the social workers of Tbilisi (12 participants) and for employees of the Ministry of Internal Affairs, on the topic: Coordination of the Police and Social Service Agency on Domestic Violence and Child Abuse Facts (total number of the participants-21);

5. On 15-16 of September 2018–the association "Hera XXI" held the training for social workers, on the topic: Sexual and Reproductive Health in Social Work Practice (16 participants); the purpose of the training was the delivery of the thematic knowledge regarding the effective consultancy and referral of the targeted groups to the social workers.

7. On 14-18 of May 2018, for the senior social workers of Social Service Agency, there was held the training, on the topic: "Social Work during the Violence Against the Women", which was organized by the State Fund for Protection and Assistance of Victims of Human Trafficking (19 participants).

8. On 19-20 of June 2018- the Interagency Coordination Council which is implementing activities addressed against the Human Trafficking, in collaboration with the International Centre for Migration Policy Development (ICMPD), with the involvement of Georgian and foreign experts, held the training on the human trafficking issue (10 participants).

9. On 26-28 June 2018 -State Fund for Protection and Assistance of Victims of Human Trafficking, within the framework of USAID grant funding project "Reducing of Domestic Violence in Georgia", held the coordination meeting for the senior social workers of Adjara, Kakheti, Shida Kartli, Imereti, Isani-Samgori, Vake-Saburtalo Agencies, for the staff of Guardianship-Care and Social Programs Departments (9 participants)

10. Including 15-31 of July 2018- State Fund for Protection and Assistance of Victims of Human Trafficking, according to the schedule developed within the framework of USAID grant funding project "Reducing of Domestic Violence in Georgia", held the training for the social workers of the Agency, on the topic: "Social Work in the Context of Gender-Based Violence" (229 social workers, 8 employees of the Agency)

12. In the month of December 2018, the Training Centre of the Justice House has trained the employees of Social Service Agency on the juvenile justice issues (10 trainers), later the specialization in the juvenile justice issues have passed the social workers (67 social workers).

## **2019**

1. On 24–27 of June 2019, the training on the topic: „Child’s Labour Exploitation (Children's Begging) was held in Batumi (5 participants - 1 Chief of the Division, 4 senior social workers). It was planned by the Ministry of Justice of Georgia, as the Head Department of the Interagency Coordination Council, implementing activities against the Human Trafficking, in collaboration with the International Centre for Migration Policy Development and under the financial support of the United States Bureau of Narcotics and Law Enforcement (INL).
