# Re-thinking the RTD



### 'core norm' of the RTD

'the right of peoples and individuals to the <u>constant</u>

<u>improvement</u> of their well-being and to a national and global
environment conducive to just, equitable, participatory and
human-centred development respectful of all human rights.'







### Case Study – Ebola Virus Disease (EVD) in WA/Nigeria.

- Nearly 10,000 cases of the Ebola Virus Disease (EVD), with less than 50 outside 3 WA countries.
- Over 5,000 confirmed deaths since latest outbreak commenced in December 2013.
- EVD imported into Nigeria by index case on July 20, 2014.
- Last case reported on Sept 8, country declared EVD free on Septr22.

### Why this Research?

- Critical appraisal of actions or inactions of Nigerian Government, International Community in the EVD case.
- Role of international human rights law? African Charter, UNDRTD?
- Distil important lessons learnt.





### The African Charter



#### **Government's Legal Liability Under Regional Law**

Article 22 of the African Charter on Human and Peoples Rights of 1981 (African Charter) confers legally binding Right to Development on African peoples.

African Commission's Jurisprudence:

Ogoni Case (2001), Endorois Case (2009).





### **Nigerian Government and Ebola - Findings**

Government discharged duty to Nigerian peoples under PRTD - protection, prompt and adequate <u>action</u> <u>after</u> the EVD entered Nigeria. Duty to <u>other</u> West Africans?

PRTD - Government was lacking in its duty owed to Nigerian peoples - protection, due diligence and adequate <u>preventive</u> steps against the <u>known threat</u> of the EVD before it reached Nigeria.

RTD - Government ought to continuously take the necessary steps to have highest standard of healthcare possible for Nigerians – <a href="before">before</a> the current EVD case.

Problems of non-justiciability and poorly defined State responsibility – African Charter and UNDRTD.

### **International Community and Ebola - Findings**

RTD – Response of the international community to the current crisis has been delayed, with unfortunate results.

**UNDRTD** - Duty of International Cooperation

No legal accountability imputed onto global community and international organizations for failing to ensure that West Africa received prompt and adequate assistance.

### Re-thinking the RTD

#### Without legal liability where will the RTD be in the future?

- Apply principles of State Responsibility to the RTD
- Hold States accountable for RTD (African Charter, UNDRTD)
- Legal liability for international cooperation imperative under UNDRTD in such extreme conditions as the Ebola case
- Who determines extreme case? States or Int'l Orgs?
- Read legally binding RTD into several other HR treaties
- Promote legal liability of the RTD inferred from customary international law.
