Growing, yet uneven attention to heritage and cultural rights in crisis

- · "hidden" heritage bias
- Main focus on the material, tangible and monumentoriented perspectives
- Integration of intangible heritage, cultural identity and cultural rights largely incipient
- Cultural rights disconnected from mainstream crisis and peace-building action

Recognizing the cultural (rights) dimension of crisis, conflict and peace building

- Humanitarian crisis and conflict: high levels of risk and protection needs
- Human rights violations, impunity and strong cultural dimension
- Heritage, cultural identities and diversity weakened, instrumentalized or neglected.
- · Cultural rights undermined

The missing cultural rights link

Cultural identity, ethnicity and religion often central to crisis and conflict from matters of recognition to matters of redistribution

Yet, cultural rights often neglected compared to both heritage questions and wider human rights issues.

Diversity even reduced to staff skill rather than a question of organizational capacity

The *central* need for a holistic approach to cultural rights and heritage in crisis, conflict & peace building

Integration of culture and cultural rights often piece-meal and marginal

A narrow, often material, take on culture and heritage predominant

Concepts of cultural property, cultural heritage and cultural rights are at times used interchangeably obscuring differences

Holistic approach needed to address cultural and identity complexity, resources and resilience effectively
