## Mandate of the Special Rapporteur on the right to adequate housing

## I. Background and questionnaire (Civil society organizations)

For her next report to the UN General Assembly, 71<sup>st</sup> session, the Special Rapporteur on adequate housing as a component of the right to an adequate standard of living and on the right to non-discrimination in this regard, Ms Leilani Farha, intends to focus on the intimate link between the right to life and the right to adequate housing.

The fiftieth anniversary of the adoption of the International Covenant on Economic, Social and Cultural Rights (ICESCR) and the International Covenant on Civil and Political Rights (ICCPR) provides an occasion to assess the effect of the division of the unified rights in the Universal Declaration of Human Rights into two categories, placing the right to life within the ICCPR and the right to adequate housing in the ICESCR.

While it is well recognized that the right to life belongs "at the same time to the domain of civil and political rights as well as economic, social and cultural rights" the Special Rapporteur is concerned that violations of the right to life linked to homelessness and inadequate housing have too often been ignored. The report will consider whether a pattern of neglect of issues of inadequate housing and homelessness in relation to the protection of the right to life can be traced to false divisions between categories of rights, or to the misunderstanding that the right to life imposes primarily negative obligations on states, rather than positive obligations.

The report will review data on health, mortality and morbidity rates linked to inadequate housing and homelessness as well as considering the lived experiences that lie behind the statistics. It will explore the nature of state obligations to take positive measures to protect the right to life in this context and examine responses of courts, human rights bodies and governments to violations of the right to life linked to inadequate housing and homelessness. The report will consider whether particular groups such as women, indigenous peoples, people with disabilities, migrants, and others are disproportionately affected by violations of the right to life linked to inadequate housing and homelessness.

In the context of preparing her Report, the Special Rapporteur would like to receive contributions and views from civil society and Indigenous peoples' organizations addressing the following issues.

- 1. Please provide any statistical indicators or other evidence regarding the health, mortality and morbidity consequences of inadequate housing and homelessness in your country on vulnerable groups, including documentation (visual or otherwise) of the lived experiences behind these numbers and of particular circumstances of which your organization is aware.
- 2. Explain how the protection of the right to life in your state's (region or area of work) constitution or human rights legislation extends to violations resulting

from alleged failures of governments to adequately address homelessness or inadequate housing. Please provide examples of attempts to secure access to justice for such violations of the right to life and describe the result. Please provide references to any relevant cases or initiatives.

- 3. Has the disproportionate effect of homelessness and inadequate housing on particular groups (eg: persons with disabilities, Indigenous peoples, women experiencing violence, etc.) been recognized by courts or human rights bodies in your country (region/area of work) as an issue of discrimination? Please provide examples.
- 4. What measures does your organization promote or recommend to ensure access to justice for violations of the right to life resulting from homelessness and inadequate housing and to ensure that governments address these violations with appropriate urgency and commitment (eg: application of international human rights law; legal reform; institutional reform).
