Iraq contribution concerning human rights council resolution 33/25
entitled: “Expert Mechanism on the Rights of Indigenous Peoples”

- The people of Iraq are one Nation with diverse sects, ethnic and religions, who have lived in the land of Iraq since the creation.
- The five-year national strategies and plans (2010-2014), (2013-2017) and the Millennium Development Goals adopted the principles of equality and non-discrimination between different segments of Iraqi society, alleviation of poverty and poor socio-economic status of vulnerable groups. The poverty alleviation strategy (2010-2014) and its operational programs came in line with the development plans, it dealt with community diseases and the economic, educational and health conditions and identified the poverty line and poverty rates and illiteracy rates within the Iraqi community at the governorate level and at the level of the environment and other administrative levels such as districts, Villages, etc., and in its measures it did not aim to protect or care for a sect or race at the expense of another sect or race, and in particular the scope targeted vulnerable groups.
