## I. INDIGENOUS PEOPLES

# SUB-REGIONAL SEMINAR ON THE RIGHTS OF INDIGENOUS PEOPLES IN CENTRAL AFRICA

A sub-regional seminar on the rights of indigenous peoples was organized jointly by the ILO and the OHCHR in Yaoundé from 26 to 28 May 2010. The seminar convened government and indigenous participants from Burundi, Cameroon, Central African Republic (CAR), Congo Brazzaville, Democratic Republic of Congo (DRC), Gabon, Rwanda and Chad. The seminar was opened by the Minister of Foreign Affairs of Cameroon with the participation of the Director of the Sub-regional Office of the ILO and the Director of the Sub-regional Office of the OHCHR.

The seminar provided an opportunity for participants to familiarize themselves with international instruments and mechanisms, including the United Nations Declaration on the Rights of Indigenous Peoples, ILO Conventions and supervisory bodies, work of the Expert Mechanism on the Rights of Indigenous Peoples, recommendations of the African Commission Working Group on indigenous communities/populations, as well as recent national developments in the sub-region concerning indigenous peoples.

Some of the key conclusions drawn are: increased openness for discussing indigenous peoples' issues among governments in the sub-region; ongoing discussion about the term "indigenous peoples" and its implications; the need for continued support to awareness-raising combined with the need to engage with the specific processes at the country-level and advance the right to consultation and participation of indigenous peoples; the need to further build the capacity of indigenous peoples' organizations in the sub-region.

# ISOLATED INDIGENOUS PEOPLES

OHCHR IPMS undertook a mission to Paraguay and Brazil from 17 to 26 May 2010 to carry out consultations on guidelines for the protection of indigenous peoples in isolation or initial contact in the Amazon region and Gran Chaco.

The consultation in Paraguay was held at the Ministry for Foreign Affairs with representation from relevant governmental departments, the Indigenous Institute of Paraguay, indigenous organizations, the national human rights institution, the UN system and civil society and included several academics and experts.

The consultation in Brazil was held at the Israel Pinheiro Conference Centre outside Brasilia. The meeting was organized by FUNAI, the National Indian Foundation with participation mainly from within its own organization, some outside experts, academics and NGOs.

# 3<sup>RD</sup> EMRIP SESSION (12-16 JULY 2010)

The 3<sup>rd</sup> Session of the Expert Mechanism on the Rights of Indigenous Peoples (EMRIP) will take place from 12 to 16 July 2010 in Geneva.

Over 500 registered participants will get acquainted with the EMRIP Progress report on the study on indigenous peoples and the right to participation in decision-making, which encompasses the international human rights framework, indigenous peoples' internal decision-making, and participation in decision-making mechanisms linked to State and non-State institutions and processes affecting the indigenous.

Main agenda items are the progress report and a general discussion on the use of the Declaration on the Rights of Indigenous Peoples at the international, regional and national levels to advance the rights of indigenous peoples. Briefings and side events will also take place throughout the session.

# ACTIVITIES OF THE SPECIAL RAPPORTEUR ON THE SITUATION OF HUMAN RIGHTS AND FUNDAMENTAL FREEDOMS OF INDIGENOUS PEOPLE

#### **Country Visits**

Special Rapporteur on human rights and fundamental freedoms of indigenous people, Mr. James Anaya, visited Guatemala between 14 and 18 June 2010. The purpose of the visit was to analyze the implementation of international norms regarding consultation with indigenous peoples in the country, in particular in relation to natural resource extraction, and with a special emphasis on the situation of the Marlin Mine in the municipalities of Sipacapa and San Miguel Ixtahuacán.

#### **Public Statements**

SR called for dialogue and understanding between political actors and indigenous organizations in Ecuador. (8 June 2010)

SR launched an advance version of his report on Australia and emphasized that "Having suffered a history of oppression and racial discrimination, including dispossession of lands and social and cultural upheaval, Aboriginal and Torres Strait Islander peoples endure severe disadvantage compared with non-indigenous Australians." (June 2010)

SR signed a joint statement on the World Day for Cultural Diversity for Dialogue and Development. (21 May 2010)

SR noted with satisfaction the adoption of the "Law on the right to previous consultation of indigenous and tribal peoples as defined by the ILO Convention 169 concerning Indigenous and Tribal Peoples in Independent Countries" by the Congress of the Republic of Peru. (19 May 2010)

SR also welcomed the agreement in principle of the European Nordic governments to restart negotiations on a Nordic Sami convention with the participation of Sami leaders. (16 April 2010)

# 6<sup>TH</sup> INTER-AGENCY GROUP ON MINORITIES (IAGM) MEETING

OHCHR Indigenous Peoples and Minorities Section hosted the 6th meeting of the Inter-Agency Group on Minorities on 18 May 2010.

The IAGM work is focused on maintaining coordinated progress in the field of minority rights throughout the UN System. The 6<sup>th</sup> meeting brought together several OHCHR staff members and representatives of UNICEF, UNDP, UNESCO, ILO and IPU. The meeting, inter alia, examined the work of the 2<sup>nd</sup> Session of the Forum on Minority Issues dealing with minorities and effective political participation, the work of the Independent Expert on minority issues and discussed mainstreaming of the Minority Declaration. IPU presented its project 'Promoting Inclusive Parliaments: The representation of minorities and indigenous peoples in parliament', UNICEF elaborated on its ongoing process aimed at identifying possible ways to mainstream minority rights in a more systematic manner, OHCHR Indigenous and Minority Fellowship Programme was presented, and the participants also discussed follow-up to the recently adopted Human Rights Council resolution (HRC 13/12) on the rights of persons belonging to national or ethnic, religious and linguistic minorities.

The participants also discussed 'Marginalized Minorities in Development Programming: a UNDP Resource Guide and Toolkit' which is intended to assist in responding to minority issues in development processes. The Resource Guide, prepared in co-operation with OHCHR and available online at <a href="http://tinyurl.com/UNDP-resource-guide">http://tinyurl.com/UNDP-resource-guide</a>, has been completed and its roll-out is being planned.

## REPORT ON THE RIGHTS OF MINORITIES AT THE HRC

The High Commissioner's report on the rights of persons belonging to national or ethnic, religious and linguistic minorities will be presented at the 15<sup>th</sup> Session of the Human Rights Council. It outlines relevant developments of the UN human rights bodies and mechanisms, as well as activities undertaken by the OHCHR at Headquarters and in the field that contribute to the promotion of and respect for the provisions of the Declaration on the Rights of Persons Belonging to National or Ethnic, Religious and Linguistic Minorities.

### WORK OF THE INDEPENDENT EXPERT ON MINORITY ISSUES

#### **Country Visits**

5-16 July 2010: The Independent Expert on minority issues, Ms. Gay McDougall, will conduct a visit to Viet Nam to hold consultations on minority issues and to examine the human rights situation of the country's numerous minority groups.

### **Public Statements**

The Independent Expert on minority issues, the Special Rapporteur on extrajudicial, summary or arbitrary executions, and the Special Rapporteur on contemporary forms of racism, racial discrimination, xenophobia and related intolerance expressed their alarm and deep concern about ethnic tensions that have erupted into violence in the south of Kyrgyzstan. (15 June 2010)

The Special Rapporteur on the human rights of migrants, the Special Rapporteur on contemporary forms of racism, racial discrimination, xenophobia and related intolerance, the Special Rapporteur on the situation of human rights and fundamental freedoms of indigenous people, the Independent Expert in the field of cultural rights, the Special Rapporteur on the right to education, the Independent Expert on minority issues expressed serious concern over laws recently enacted by the state of Arizona, United States of America that affect minorities, indigenous people and immigrants and potentially subject them to discriminatory treatment. (10 May 2010)

The attacks against Ahmadis in Pakistan were strongly condemned by the Special Rapporteur on freedom of religion or belief, the Independent Expert on minority issues and the Special Rapporteur on extrajudicial, summary or arbitrary executions. (28 April 2010)

# INDEPENDENT EXPERT ON EXTREME POVERTY ANNUAL REPORT

The 2010 annual report of the independent expert on extreme poverty addresses the role that social protection systems play in reducing extreme poverty and contributing to the realization of human rights of older persons.

It mentions that outreach must be specifically designed to overcome illiteracy and linguistic barriers that may impair the access of older people from minorities, indigenous or migrant communities (e.g. by making information available in languages used by minorities and indigenous peoples).

## COMMITTEE ON THE RIGHTS OF THE CHILD (CRC)

The Committee on the Rights of the Child held its 54<sup>th</sup> session between 25 May and 11 June 2010 in Geneva during which it considered the following countries: Argentina, Belgium, FYR of Macedonia, Grenada, Japan, Nigeria, and Tunisia. Concluding observations and recommendations regarding minorities and/or indigenous peoples were addressed to Argentina, FYR of Macedonia, Japan, and Nigeria.

In the same session, the CRC also considered the following countries under the Optional Protocol to the CRC on the Sale of Children, Child Prostitution and Child Pornography: Argentina, Belgium, Colombia, FYR of Macedonia, Japan, and Serbia. Concluding observations and recommendations on the rights of indigenous and Afrodescendant children were addressed to Colombia, and regarding the Roma children to FYR of Macedonia and Serbia.

The following countries were considered under the Optional Protocol to the CRC on the involvement of children in armed conflict Argentina, Colombia, Japan, FYR of Macedonia, and Serbia. Concluding observations and recommendations regarding the rights of indigenous and Afrodescendant communities were addressed to Colombia.

### HUMAN RIGHTS COUNCIL AND THE UPR

At its 14<sup>th</sup> regular session (31 May - 18 June 2010), the Human Rights Council adopted the reports of the Working Group on the Universal Periodic Review on 16 countries: Angola, Bolivia, Bosnia and Herzegovina, Egypt, El Salvador, Fiji, Gambia, Iraq, Islamic Republic of Iran, Italy, Kazakhstan, Madagascar, Nicaragua, Qatar, San Marino, Slovenia. Conclusions and recommendations to countries regarding the rights of indigenous peoples (I) or minorities (M) were addressed to Bosnia and Herzegovina (M), Egypt (M), El Salvador (I, M), Fiji (I, M), Iraq (I, M), Islamic Republic of Iran (M), Italy (M), Kazakhstan (M), Nicaragua (I), and Slovenia (M).

The 8<sup>th</sup> UPR session took place between 3 and 14 May 2010. The countries reviewed were: Armenia, Belarus, Guinea, Guinea Bissau, Kenya, Lesotho, Kiribati, Kuwait, Kyrgyzstan, Lao People's Democratic Republic, Grenada, Guyana, Spain, Sweden, and Turkey. Conclusions and recommendations to countries regarding the rights of indigenous peoples (I) or minorities (M) were addressed to Armenia (M), Belarus (M), Guyana (I,M), Kenya (I,M), Kuwait (M), Kyrgyzstan (M), Lao People's Democratic Republic (I, M), Spain (M), Sweden (I,M), and Turkey (M).

The 9<sup>th</sup> session of the UPR Working Group is scheduled to take place from 1 to 12 November 2010. The following countries will be reviewed: Lebanon, Liberia, Libyan Arab Jamahiriya, Malawi, Maldives, Marshal Islands, Mauritania, Micronesia, Andorra, Bulgaria, Croatia, Honduras, Jamaica, Mongolia, Panama and United States of America.

The 10<sup>th</sup> session of the UPR Working Group is scheduled to take place from 24 January to 4 February 2011.

13 September-1 October 2010: The 15<sup>th</sup> regular session of the HRC will take place in Geneva. It will, inter alia, include a report on the rights of persons belonging to national or ethnic, religious and linguistic minorities. Special Rapporteur on the situation of human rights and fundamental freedoms of indigenous people, EMRIP and the HC will also report on the activities to advance the rights of indigenous peoples.

13 September-1 October 2010: The 55<sup>th</sup> session of the Committee on the Rights of the Child will take place in Geneva. During the session State reports of the following countries will be considered: Angola, Burundi, Guatemala, Montenegro, Nicaragua, Spain, Sri Lanka, Sudan. The committee will also consider (under the Optional Protocol to the CRC on the Sale of Children, Child Prostitution and Child Pornography) reports from Bosnia and Herzegovina, Montenegro, Nicaragua, Sierra Leone, and (under the Optional Protocol to the CRC on the involvement of children in armed conflict) reports from Bosnia and Herzegovina, Montenegro, Nicaragua, Sierra Leone, Sri Lanka and Sudan.

October 2010: The United Nations Independent Expert on Minority Issues, Ms Gay McDougall, will report on minority rights and conflict prevention to the General Assembly at its 65<sup>th</sup> session in New York.

4-22 October: The Committee on the Elimination of Discrimination against Women will hold its 47<sup>th</sup> session. During the session State reports of the following countries will be considered: Bahamas, Burkina Faso, Chad, Czech Republic, Malta, Tunisia and Uganda.

28 October 2010: The 3<sup>rd</sup> meeting of States parties to the Optional Protocol to the Convention against Torture and other Cruel, Inhuman or Degrading Treatment or Punishment will be held in Geneva.
