

WORKING LANGUAGES

The working languages of the Session will be English and French. Simultaneous interpretation will be provided in these working languages as well as in Russian and Azerbaijani.

- Participants are reminded that the Secretariat will not be able to type, translate or reproduce documents other than those that have a direct bearing on the session of IBC. If participants wish to have their intervention made available in printed form, they are kindly requested to bring sufficient typed copies with them. A special desk for this purpose will be available in front of the meeting room.

ON-SITE FACILITIES

ENTRY FORMALITIES FOR AZERBAIJAN

- A valid passport, with a visa if necessary, is required for entry into Azerbaijan. For information on this subject, participants are requested to contact the nearest Embassy or Consulate of Azerbaijan and, if needed, apply for entry visas well in advance.
- Participants can also consult the Internet site of the Ministry of Foreign Affairs of Azerbaijan (www.mfa.gov.az).

Arrival at Heydar Aliyev International Airport

- The airport is situated about 25 km from the centre of Baku.
- A reception service ("UNESCO-IBC" desk) will be organized at the airport from 7:00 a.m. to 7:00 p.m. on Sunday 29 May and Monday 30 May to provide information and assistance regarding transport to hotels. Participants are therefore invited to refer to this "UNESCO-IBC" desk upon arrival. Shuttle buses could be organized from the airport to the hotels and back (to be confirmed).

CURRENCY AND EXCHANGE

- The national currency is the Manat. US dollars, Euros, credit cards (Visa, American Express and MasterCard) are accepted in the major hotels, restaurants and banks. Foreign currency can be exchanged at hotels, bureaux de change and banks (open from Monday to Friday from 9:00 a.m. to 5:00 p.m.). A network of ATM machines is also available.
