## QUESTIONNAIRE -

## IMPACT OF ARMS TRANSFERS ON THE ENJOYMENT OF HUMAN RIGHTS

- 1. Please identify the ways that arms transfers impact on the enjoyment of human rights. Are there rights that are particularly affected? Are there groups of rights-holders which are particularly affected?
- Some of the ways that arms transfers impact on the enjoyment of Human Rights are as hereunder:-
  - Individual killing;
  - Mass killing;
  - Civil war:
  - Genocide:
  - Terrorism, etc
- Mauritius is the signatory of relevant conventions on arms and weapons. It has also
  enacted the Firearms Act 2006 (amended in 2016) so as to be in line with international
  treaties and conventions. Furthermore, there are well established policies and procedures
  respecting the import, export, transit, etc, of arms and weapons.
- By virtue of the above control mechanisms, risk of possible violations to Human Rights and human sufferings, is quasi inexistent.
- In light of the foregoing, the rights of the individuals or groups are not affected.
- 2. If your Government undertakes arms transfers, please indicate whether your Government assesses the impact that each arms transfer may have on the enjoyment of human rights. What considerations are taken into account when making these assessments, including national procedures and/or laws and international obligations and standards? On what information and/or sources of information does your Government base its assessments?
- The Government of Mauritius does not undertake arms transfers.

- The risk of any violation of Human Rights in such State.
- Viability of procedures to:-
  - Assess the reliability of the existing system and procedures;
  - Analyse integrity of stakeholders involved in the transfer procedures;
  - o Scrutinise the authenticity of relevant documents; and
  - Ensure timely exchange of intelligence/cooperation with friendly countries, Interpol, Counter Terrorism Unit and Local Shipping Agents.
- 4. If your Government undertakes arms transfer, has your Government in the past refused to authorise a proposed arms transfer to arms transfers on the basis that the arms transfer would impact on the enjoyment of human rights? If so, please identify the factors that were taken into consideration in making this decision, and the nature of the human rights that would have been impacted by such the proposed transfer?
