Dear Mr. Madrigal-Borloz:

We are grateful for the opportunity to provide input to inform the Independent Expert's forthcoming report on the impact of the COVID-19 pandemic on the human rights of lesbian, gay, bisexual, transgender, and gender diverse (LGBT) persons, communities and/or populations.

The Williams Institute is a research center dedicated to conducting rigorous and independent academic research on sexual orientation and gender identity, including on the lived experience and well-being of LGBT people both inside the United States and globally, as well as rights and legal protections related to sexual orientation and gender identity.

Below we include citations and links to the full text of research published by the Williams Institute that specifically addresses the vulnerabilities of LGBT people to COVID-19. We aim to add to the Independent Expert's record of research and shed light on the question of "information available to the State as to the impact of the COVID-19 pandemic on the general situation of LGBT persons and their access to education, housing, health and employment and on their living conditions." Given the paucity of data on sexual orientation and gender identity that is collected globally, there is little research as to the precise impact of the pandemic on LGBT people. Williams Institute scholars have analyzed data sets within the United States to generate insights into the particular risks facing LGBT people that likely increase their vulnerability to COVID-19.
