Planning and vision, 2020-2023 - Report to the human rights council by the Special Rapporteur on the Human rights to safe drinking water and sanitation, Pedro Arrojo-Agudo



During the month of June (and previous months), I have been working on my first report on the vision and planning for the first three years of my mandate from 2020 to 2023. (See the first sneak preview [here](#))

In my report, I outline my vision of the mandate:

1. to establish an ecosystem approach that requires integrated management of the different uses and functions of water; and
2. to clarify steps to promote democratic water governance under a sustainable and human rights-based approach in different contexts.

Promoting the democratic governance of water




Advancing the realisation of the human rights to safe drinking water and sanitation, restoring the sustainability of aquatic ecosystems

#### VISION OF THE MANDATE



I also outline my objectives during the first three years as Special Rapporteur: (a) promoting the democratic governance of water, (b) advancing the realization of the human rights to water and sanitation while restoring the sustainability of ecosystems, and (c) promoting water as a key to collaboration and peace.

In the report, you will also find specific plans for my mandate, including themes of my reports to the Human Rights Council and General Assembly, my plan to strengthen dialogue with actors in the water and sanitation sector, and the focus of my communications and country visits.

Antigua and Barbuda ([30 March 2021](#)) Information received concerning the impacts of the development of an airport and the Barbuda Ocean Beach Club, a luxury tourist structure, on the human rights of the population of Barbuda, including to food, housing, water and sanitation and to a healthy environment and cultural rights.
