


# Needs Assessment for the Economic, Social and Cultural Rights Knowledge Hub at OHCHR

**360** Responses received from 15 July to 17 September 2024


### 1. I need information about economic, social and cultural rights



- To work with other non-state actors, such as businesses.
- To disseminate information to other agencies, programmes and institutions belonging to the United Nations System. (Translated)
- To translate economic, social and cultural rights (ESCR) into tangible programmes and initiatives.
- To assess the attention given by the UN human rights ecosystem to ESCR.
- To follow OHCHR's work related to ESCR and the right to development and assess whether all human rights are treated in an equal and balanced manner as mandated.



#### 2. What information about economic, social and cultural rights do you look for?




- Economic, social and cultural rights of people with disabilities and those belonging to ethnic communities, as well as of women living in rural areas and community leaders. (Translated)

- Finding the most relevant information and filtering may become challenging sometimes. Summaries of key documents are also needed.


### 4. Do you know about or use other hubs or resources about ESCR or related issues? Please indicate the name of the hubs and resources and any comments.







### 6. Please tell us what you would be available to contribute to the ESCR knowledge hub, how, and how often you would be willing to do it?

#### Highlighted Responses:

- Production of educational communication pieces and training workshops for mass, alternative, and community media at the national, departmental, and local levels, with an ethnic, gender, and human rights focus. (Translated)
- Training on ESCR rights in Arabic, producing learning tools and products (videos, infographics, etc.) in Arabic (and English), developing exercises and initiatives on ESCR (moot court competition, research competition, etc.) in Arabic, General knowledge sharing products, and organizing "regional" initiatives related to ESCR in the Arab region in Arabic.
- To contribute as a global enterprise, on the one hand, we will carry out our own practices/pilots in protecting the economic, social and cultural rights of stakeholders such as enterprises, supply chains, and communities, especially in overseas coconstruction. On the other hand, we can pass on our experience to industry and value chain partners to strengthen the new energy industry chain's understanding and fulfillment of the responsibility to respect economic, social and cultural rights. - Fragmentation of information on ESCR and related topics represents a significant challenge. When the necessary data and resources are dispersed in different places, finding and consolidating information becomes a difficult and time-consuming task. This problem not only increases search time but can also lead to inconsistencies and difficulties in validating information. Furthermore, fragmentation can create barriers to effective collaboration between different actors and organizations. It is crucial to promote initiatives that centralize and facilitate the exchange of information to improve the accessibility and coherence of available resources on ESCR. (Translated)
