FAMILY POWER

A research and communication project, initiated in The Netherlands, to show HOW vulnerable children worldwide can grow up in a safe, caring and permanent family, visualizing and sharing existing best practices from all parts of the world. As a result, a training and consultancy program for small NGOs will be developed in order to strengthen cross-border cooperation.

Family Power is a joint initiative of 9 Private Initiatives (PIs) in the Netherlands and their international Partner Organizations (IPOs). During 2021 - 2022 those organizations will share their experiences in a structured way and will make visible HOW vulnerable children can grow up in a safe, caring and permanent family despite harsh conditions. The ultimate common goal: helping more children grow up in a family successfully!

NETWORK PARTNERS

Family **Power** is working together with network partners like Wilde Ganzen, Partin, **Better Care Network** Netherlands (BCNN), University, Radboud **Dutch** Coalition **Disabilities** and Development (DCDD), Family for Every Child and Transform Africa Alliance. They play an important advisory within role the project.

CASE STUDY

All participating organizations will provide data and learnings from a running case project or program aimed at family-based care for vulnerable children. Vulnerable children are defined as children without adequate parental care or being at risk of losing that care (Faith to Action, 2018; UNGA, 1989). An important group are special needs children. The cases are varying from kinship care to de-institutionalizing and from preventive care to national public policy change. A literature study is providing the theoretical framework, building a case study on academic level. A challenge we are currently taking on with the support of the Radboud University, Nijmegen, Holland. The investigation will focus on the definition of factors that accelerate and that complicate successful implementation of family-based care by IPOs.

DATA COLLECTION

The IPOs play a crucial role in the research. They share information about their programs, approach and experiences, including those of their employees, beneficiaries and important stakeholders. By means of questionnaires, (digital) interviews, reports and documents they are providing information to the project coordinator. In group discussions the IPOs share more in-depth knowledge and experience. All projects will be visited by the project coordinator to continue dialogue with employees and observation. Finally, a pilot will be carried out with digital storytelling, in which children share their story and process by means of self-recorded video images.





AWARENESS & INSPIRATION

The research provides more than a learning effect to those directly involved as the 'HOW' question is relevant to a bigger audience. Through a vibrant informative campaign based on tangible data and above all full of inspiring local field stories, Family Power will demonstrate to fellow organizations and sponsors/donors that good family-based care alternatives have been developed. This may give parties the confidence and conditions to further implement and grow family-based solutions worldwide, in the interest of many children. A campaign strategy is being developed around the following parameters:

- IPOs, Dutch PIs and donors as target audiences
- The actual global care reform
- Practical success stories of family-based care
- Captured by local videographers and digital story telling by the children themselves
- Supported by relevant and appealing conclusions from the research
- From the Netherlands but internationally useful.



TRAINING & CONSULTANCY

The 9 IPOs will translate the acquired knowledge training and into consultancy programs for own organization, their their local network and for interested peer organizations, worldwide. The training and consultancy activities will be delivered by the IPOs and specialised external organizations. Training consultancy and Will address issues such as transforming institutionalised care into family-based care, alternative family and community based care, network development, inclusion and advocacy. An active exchange and consultation process between the IPOs will give this further substance and shape. This way we will the work towards sustainable dissemination of collected the knowledge and practices.
