Selected legal experts for the open-ended intergovernmental working group on transnational corporations and other business enterprises with respect to human rights

July 2024

In paragraph 31 (e) of the report of the ninth session (A/HRC/55/59) of the open-ended working group on transnational corporations and other business enterprises with respect to human rights (IGWG), the working group recommended that the Chair-Rapporteur convene intersessional thematic consultations to discuss the draft legally binding instrument, in line with the mandate established by the Human Rights Council in its resolution 26/9, with the assistance of at least five legal experts, whose selection should be suggested by the Office of the United Nations High Commissioner for Human Rights (OHCHR).

It is important to note that the above-mentioned recommendation from the 9^{th} session of the IGWG was reflected in the <u>roadmap towards the 10th session of the IGWG</u>, and in procedural decision 56/116 adopted by consensus by the Council at its 56^{th} session.

On behalf of the Chair-Rapporteur, OHCHR, as Secretariat of the IGWG, issued in May 2024 a call for nominations for such legal experts to assist in their personal capacity. The call for nominations closed on 14 June 2024, at which point 102 applications were received. The Secretariat and the Chair-Rapporteur wish to convey their deepest appreciation for the number and quality of the applications received.

Of those applications that met the criteria set for selection, including the need to achieve a balanced representation, OHCHR recommended 17 people.

From those recommendations, careful and detailed analysis was undertaken by the Chair-Rapporteur with the aim of ensuring a balanced selection according to the relevant criteria agreed at the 9th session of the IGWG, as well as those elements put forward by different stakeholders during relevant consultations held during the intersessional period. Following this, the Chair-Rapporteur selected the following five main legal experts. Additionally, the Chair-Rapporteur selected five alternate legal experts who will be called upon if main legal experts are unable to perform their duties.
