Funding opportunity for Least Developed Countries (LDCs) and Small Island Developing States (SIDS) to participate in the 52nd session, 53rd session and the 54th session of the United Nations Human Rights Council in Geneva, Switzerland

The Office of the United Nations High Commissioner for Human Rights (Secretariat of the Voluntary Technical Assistance Trust Fund to Support the Participation of Least Developed Countries and Small Island Developing States in the Work of Human Rights Council) presents its compliments to the Permanent Missions of Least Developed Countries and Small Island Developing States in Geneva and New York and has the honour to inform them of the deadlines for applications to participate in the delegates programme for the 52nd (27 February – 31 March 2023), 53rd (19 June – 14 July 2023) and 54th (11 September – 6 October 2023) sessions of the Human Rights Council (HRC), as follows:

52nd session: 2 January 2023 53rd session: 15 March 2023 54th session: 25 May 2023

The Voluntary Technical Assistance Trust Fund was established pursuant to HRC resolution 19/26 adopted on 23 March 2012. Since its operationalization in 2014, the Trust Fund has assisted 198 delegates coming from 71 LDCs/SIDS to participate in a regular session of the HRC. In accordance with the mandate of the Trust Fund, LDCs and SIDS are invited to designate one Government official, at expert level, who has been working in the field of human rights for at least one year, either in the capital or in their Permanent Mission in New York, to participate in the delegates programme of the Trust Fund. The delegates programme covers the participation of a government official in one of the three regular Council sessions that are held during the year. Priority will be given to the LDCs and SIDS without a Permanent Mission in Geneva and to LDCs/SIDS that are current Members of the HRC. Former beneficiary delegates of the Trust Fund are, in principle, not eligible.

The designated government official <u>will be required to attend the full delegates programme</u>, including the mandatory two-day induction course in Geneva organized by the Trust Fund Secretariat, prior to the beginning of each regular session of the HRC (dates will be communicated at a later stage).

Based on applicable United Nations rules and regulations, the Trust Fund covers one round-trip ticket in economy class per regular session per LDCs/SIDS and the daily subsistence allowance (DSA) payable to the selected delegate for the duration of his/her mission in Geneva (not exceeding the duration of the regular session). **The Trust Fund does not cover**

health insurance costs or other expenses, including personal expenses, nor any expenses related to COVID-19 (medication, quarantine, etc.).

The delegate selected as a beneficiary of the Trust Fund is responsible for obtaining a visa (if required) and health insurance coverage. He/she is also responsible for arranging his/her own accommodation in Geneva and for covering related expenses. A daily subsistence allowance, intended to cover lodging, meals and other expenses incurred during their mission in Geneva, will be paid to selected delegates in accordance with United Nations relevant rules and regulations. The Secretariat of the Trust Fund cannot assist in securing accommodation in Geneva.

Office space for the selected delegate will have to be provided by his/her Permanent Mission in Geneva. The Secretariat will not be able to secure office space for a selected delegate from LDCs/SIDS without a Permanent Mission in Geneva.

In order to initiate the process and enable the Secretariat of the Trust Fund to make travel arrangements, an application for funding must be submitted to the Secretariat by the abovementioned deadlines.

<u>Important:</u> the application should be sent through the Permanent Mission in Geneva. For countries that do not have a Permanent Mission in Geneva, the application should besubmitted either by their Permanent Mission in New York or directly by the capital.

The application must indicate the Council session number (52nd, 53rd or 54th) in which the delegate is designated to participate, if selected. The same delegate cannot be designated for more than one regular session.

The application for funding must comprise the following five (5) mandatory documents:

- 1. A note verbale endorsing the candidature of a government official (sample attached);
- 2. The certificate of completion of the e-learning course tool on the Council for LDCs/SIDS delegates developed by the Trust Fund (available at https://www.ohchr.org/en/hr-bodies/hrc/trust-fund/tool);
- 3. A legible scanned copy of the passport of the designated delegate (the passport must be valid for at least six months after his/her return to the home country or official duty station);
- 4. A detailed curriculum vitae (CV) in English or French, in MS Word format; and
- 5. A completed "Visa information form" (attached), indicating whether the candidate needs a Schengen visa.

Designated delegates must also commit to sharing the knowledge and experience gained during the programme with their colleagues in the government.

Only applications containing the five mandatory documents (see above) and submitted prior to the set deadlines will be accepted. Applications should be sent <u>in one single email</u> to <u>ohchr-sidsldc@un.org</u> and <u>ohchr-registry@un.org</u>, indicating in the subject line of the email *LDCs/SIDS Delegates Programme HRC52 [or HRC53 or HRC54, as applicable] - name of country, name of delegate*. The Secretariat will contact only the selected delegates.

The attention of applicants is drawn to the fact that the delegates programme may be adjusted or cancelled due to the evolving situation of the COVID-19 pandemic and ensuing restrictions that may be imposed by the Swiss authorities and the United Nations Office at Geneva.
