Excellencies,

In my capacity as President of the Human Rights Council, I have the honour to submit for your attention the candidate proposed for the vacancy of member from Western European and other States in the Working Group on the use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination, one of the three vacancies of mandate holders that are to be filled at the fifty-sixth session of the Human Rights Council.

In follow-up to my letter of 25 June 2024, and in accordance with paragraphs 52 and 53 of the annex to Council resolution 5/1, upon receipt of the Consultative Group's addendum of 25 June 2024, to its report dated 20 May 2024, I have held broad consultations in particular through the regional coordinators and based on the recommendations of the Consultative Group, to ensure the endorsement of my proposed candidate.

Following my consultations with States and other relevant stakeholders, I have decided to follow the recommendation of the Consultative Group for this vacancy and therefore to propose Ms. Joana LOPES DE DEUS PEREIRA (Portugal) for appointment as member from Western European and other States in the Working Group on the use of mercenaries as a means of violating human rights and impeding the exercise of the right of peoples to self-determination.

For the sake of completeness, allow me to recall that I also followed the recommendations of the Consultative Group, included in its report of 20 May 2024, for the following two vacancies of mandate holders. The complete list of candidates proposed for appointment as mandate holders at the 56th session of the Human Rights Council is enclosed.

For the mandate of Special Rapporteur on the situation of human rights in the Islamic Republic of Iran, I proposed for appointment Ms. Mai SATO (Japan).

With regard to the Working Group on the issue of human rights and transnational corporations and other business enterprises, member from Eastern European States, I proposed for appointment Ms. Lyra JAKULEVIČIENĖ (Lithuania).
