## Submission by swisspeace (Swiss Peace Foundation) on Resolution 51/35 – Technical assistance and capacity-building to address the human rights implications of the nuclear legacy in the Marshall Islands

## Key recommendations

The long-term preservation of records is a prerequisite for dealing with the past (or transitional justice) processes aiming to overcome legacies of human rights violations and breaches of international humanitarian law. To promote the 'right to truth' of the Marshall Islands' inhabitants regarding their nuclear legacy, an archival strategy considering both local specificities and global best practices is required. The following considerations are relevant for such a strategy:

- The preservation of existing records is the main objective of dealing with the past. It needs to consider different kinds of archives and sources related to the islands' nuclear legacy, which have to be mapped and assessed.
- The creation and transfer of security copies to be based outside of the Marshall Islands is recommended. A successful example is the hosting of a security copy of the records produced by the Nuclear Claims Tribunal in view of securing their long-term access by the Swiss Federal Archives.
- Original records based in the Marshall Islands must be safeguarded from harmful environmental impacts related to raising sea levels and temperatures as well as climate shocks.
- In addition to preserving the archives of the Marshall Islands Nuclear Claims Tribunal other sources, records and collections produced and/or hosted by civil society organizations must be considered in long-term preservation.
- Records providing testimonies of lived experiences are vital and particularly fruitful for future memorialization and educational activities addressing the islands' nuclear legacy.
