## DECLARATION

### **The Rebirth of the Kingdom of Kush as a Sovereign State.**

June 3<sup>rd</sup>, 2023

Whereas, prior to the year 1993 Bir Tawil (a territory located between Egypt and Sudan) has not been claimed by any party and, therefore, was referred to as Terra Nullius "no man's land;"

Whereas, in June 1993 Founding Members of the Rebirth of the Kingdom of Kush Global Movement have first planted a flag and, in accordance and compliance with the applicable international laws claimed Bir Tawil as a location of the Kingdom of Kush and a new home for the African Diaspora;

For the benefit of 1.6 billion people of African descent around the world and the entire human race, we hereby declare that on March ... year 2023, on the territory of Bir Tawil, in accordance and full compliance with the applicable international laws, accompanied by the Members of the Royal Council, representatives of the government, as well as the citizens of the Kingdom of Kush, Her Royal Majesty Queen Mother Dr. Delois



# KINGDOM OF KUSH

Blakely has once again proclaimed the territory of Bir Tawil as the Sovereign Nation of the Kingdom of Kush ("Kingdom").

The Kingdom will become a state analogous to Singapore and will have modern cities similar to Dubai. It will attract and welcome people of all races and religions. The Kingdom will serve as an education and cutting edge technology empowerment cradle for generations to come. It will help bring economic prosperity and social stability to the entire continent.

In addition, with the Kingdom now functioning as a sovereign state, the African Diaspora has the "right of return" to a place it can call home. This is in accordance with the U.N. General Assembly Resolution 194 (III) The Universal Declaration of Human Rights (10 December 1948). Article 13(2) of the Universal Declaration of Human Rights states: "Everyone has the right to leave any country, including his own, and to return to his country." African Diaspora as the "sixth region" of Africa exists in the constitution of the African Union ("AU"). The Kingdom of Kush is committed to put in place the first of its kind, a legally binding instrument of commitment to these and other UN and AU major initiatives.

The Kingdom has already gained broad political and economic support in the continent. Many countries have expressed their willingness to recognize the Kingdom as a sovereign state.

The Kingdom plans to invest in education, healthcare, sustainable agriculture and technologies in its neighboring countries and the region. All this will lay the necessary foundation for consumer-focused services and create hundreds of thousands of jobs for the people of Sudan, Egypt and other countries in Africa.

The Kingdom is committed to the principles of the United Nations Charter and looks forward to working with governments, international organizations, and citizens of the world in bringing peace and prosperity to the African Continent and the world at large.
