General Recommendations International Tribunal on Evictions on climate change Case: Bangladesh - Kutubdia Island

The International Tribunal on Evictions (ITE) organized its 9th Session on Evictions due to Climate Change in Santiago de Chile and Madrid (5-8/12/2019) in interaction with the COP 25 negotiations.

The ITE is a peoples' and opinion tribunal established in 2011 by the International Alliance of Inhabitants and civil society organizations as tool of the Zero Evictions Campaign to put forced evictions from around the world in the dock. The Tribunal relies on the expertise of an international Jury of well-respected and competent individuals, as well as on the International Covenant on Economic, Social and Cultural Rights (ICESCR) and other instruments of international law, in order to pass judgment on real cases of forced evictions that constitute human rights violations, and , issued recommendations for solutions that respect human rights and the environment.

One of the cases received and selected by the ITE Steering Committee involved, with differentiated responsibilities, the Government and Institutions of Bangladesh and the Governments of the countries most responsible for global warming as a result of CO2 emission such as China, USA, India, Russia, Japan, European Union.

So we urge to give them these Recommendations through UNFCCC Secretariat.

Here you can find the formal complaint, received by the ITE Steering Committee, about the alleged case of eviction:

Bangladesh - Kutubdia Island

Almost 40,000 inhabitants of this disfigured island, whose ecosystem has been completely disrupted by cyclones and tides, have so far not received adequate responses from the state respecting all their human rights.

You can also find the General Recommendations issued by this Jury of the ITE based on the facts received and in light of international human rights obligations of each Government.

We, the International Tribunal on Evictions, offer the opportunity to respond to the issues raised with reference to the international obligations undertaken by the countries involved through the ratification of the International Covenant on Economic, Social and Cultural Rights and other International Covenants, inviting you to review.

We hope these findings spark a dialogue between your Excellency's Governments, the UNFCCC Secretariat and the representatives of the communities that have filed their comple Committee.

30 days from today's date, the Final Recommendations will be sent to your Excellency's Governments, as well as to the relevant bodies of the United Nations, to interested civil society and human rights groups.

The implementation of the recommendations will be subject to a monitoring mechanism as indicated within the General Recommendations.

We hope your Excellency's Governments and the UNFCCC Secretariat could provide us with answers by 30/09/2020 in preparation for COP 26.
