The contribution of the Government of the Republic of Iraq regarding the questionnaire from the Independent Expert on the Promotion of a Democratic and Equitable International order, which focus on the main challenges to maintaining and strengthening International Peace and Security:

First: The allocation of competences in accordance with the Charter of the United Nations represents a major obstacle towards activating International Peace and Security System and the promotion of Human Rights, especially in cases in which one of the permanent members of the security council is a party to the conflict.

Second: The Global Food crisis associated with threats to International Peace and Security both constitute major impediments to maintaining international peace and Security System.

Third: Regarding solutions, states still endeavour to provide solutions that increase the prerogatives granted to bodies other that the Security Council within the United Nations System particularly in cases involving Human Rights Violations and Humanitarian Violations accompanying armed conflict.

Fourth: Strengthening the role of each of Human Rights Institutions and Regional Organizations could be a road to solutions.
