# FOR CIVIL SOCIETY ORGANIZATIONS SUPPORTING SLAVERY SURVIVORS



For more than 30 years, the United Nations Voluntary Trust Fund on Contemporary Forms of Slavery has been accompanying survivors of slavery on their road to recovery.

The Fund channels voluntary contributions to civil society organizations that provide healthcare, shelter, food, legal representation, vocational training, education, income-generating activities and other support to slavery survivors. On average, the Fund aids over 10,000 people every year.

## KEY ELIGIBILITY CRITERIA

#### **Applicants**

- civil society entities (e.g. NGOs, rehabilitation centers, foundations, associations of victims, hospitals, legal clinics) which have:
- experience in providing redress and rehabilitation to victims of slavery
- □ been in operation for at least two years
- legal registration and a bank account matching the organization's name

#### Methodology

- □ a demonstrable victimcentered approach
- a gender perspective integrated in all project stages
- □ support provided to beneficiaries without discrimination based on race, colour, gender, language, religion, political or other opinion, national or social origin, property, birth, disability or other status.
- not covered: advocacy, awareness raising or research activities

### **Co-funding**

- □ Requested amount should not exceed two thirds of the budget of the project\*
- \* Exceptions may apply provided a satisfactory justification.





# ANNUAL GRANTS FOR DIRECT ASSISTANCE TO SURVIVORS

## **Application period**

15 January to 1 March every year

## Implementation period

1 January to 31 December of the following calendar year

### **Grant amount**

US\$15,000 to US\$35,000

### **Eligible projects**

Social, psychological, medical, vocational, educational, legal, and humanitarian services or other forms of direct services

### **Eligible beneficiaries**

Victims of contemporary forms of slavery, including:

- ☐ forced and bonded labor
- ☐ domestic servitude ☐ traditional slavery
- □ sexual slavery
- □ trafficking for the purpose of sexual or labor exploitation
- □ sale of children
- commercial sexual exploitation of children
- ☐ the use of children in armed conflict
- □ early and forced marriage
- and the worst forms of child labour

All applications must be submitted in either
