## **BACKGROUND**

In fractured societies that are grappling with legacies of conflict and large-scale human rights abuse, transitional justice can be a strategic tool to help build justice and inclusive futures. This potential of transitional justice – as a transformative policy tool that helps acknowledge experiences, reaffirm dignity, build trust, enhance inclusion, and tackle root causes of conflict – is often underutilized by States and other stakeholders.

This is deeply regrettable in a global context marked by low levels of interpersonal and institutional trust, rising social fractures and protests fomented by a loss of shared truth, and increased levels of grievance, power imbalance, inequality and other forms of marginalization that call into question the very idea of a shared social contract.

To further tap into transitional justice's potential, the United Nations adopted a new Secretary-General Guidance Note on "Transitional Justice as a Strategic Tool for People, Prevention and Peace", following a two-year UN-wide consultative process. The Guidance Note incorporates lessons learned from 20 years of practice and is to help the Organization and its practitioners to promote and use transitional justice as a strategic, flexible, and catalytic policy instrument for prevention, accountability, social cohesion, reconciliation, and sustainable development. It encourages greater innovation in the design and implementation of transitional justice support, as well as tangible and transformational impact for people and communities.

This public launch event, co-organized by a wide range of United Nations entities and co-sponsored by the Permanent Missions to the United Nations of Argentina, Morocco, and Switzerland, is the first in a series of outreach and roll-out activities. Its objective is to provide Member States and other interested stakeholders with an understanding of the strategic ways in which the United Nations seeks to support transitional justice processes, and the principles that underpin its engagement in this regard. The event brings together United Nations senior officials and practitioners, Member State representatives, and civil society actors, for a critical reflection on innovation and impact in transitional justice.


