

OHCHR is soliciting views from youth-led and youth-focused organizations and institutions on the present and future of human rights, which, together with the outcomes of the Global Youth Consultation, will inform the development of the Human Rights 75 Youth Declaration.

Key questions and types of input/comments sought

Youth-led and youth-focused organizations and institutions are asked to provide their views on the following questions:

1. What are the challenges the world is facing now? How they will affect the future of human rights, what future do you want for human rights?

The world is currently facing numerous challenges that will undoubtedly impact the future of human rights. 2. Recommendations, commitments and actions young people take towards advancing human rights in the future:

- Push for corporate responsibility and hold companies accountable for their impact on human rights.
- Join or start student groups and clubs focused on human rights issues.
- Use their careers and professional skills to support human rights causes.
- Support and participate in movements like Black Lives Matter and Me Too, which advocate for specific human rights issues.
- Call out and challenge discriminatory practices and attitudes, such as racism, sexism, and homophobia.
- Advocate for policy changes at the local, national, and international levels, such as by supporting human rights treaties and conventions.
- Donate to human rights organizations or campaigns.
- Engage in conversations and debates about human rights issues, to foster understanding and respect for diversity.
