# BRIEFING FOR THE HUMAN RIGHTS COUNCIL UNIVERSAL PERIODIC REVIEW – $5^{th}$ session, 2008

Corporal punishment of children breaches their rights to respect for human dignity and physical integrity and to equal protection under the law. It is recognised by the Committee on the Rights of the Child and other treaty bodies, as well as by the UN Secretary General's Study on Violence against Children, as a highly significant issue, both for asserting children's status as rights holders and for the prevention of all forms of violence.

The Global Initiative to End All Corporal Punishment of Children (www.endcorporalpunishment.org) has been regularly briefing the Committee on the Rights of the Child on this issue since 2002, and since 2004 has similarly briefed the Committee Against Torture, the Committee on the Elimination of Discrimination Against Women, the Committee on Economic, Social and Cultural Rights, and the Human Rights Committee. There is growing progress now across all regions in challenging this very common form of violence against children. But we are concerned that many States persist in ignoring treaty body recommendations to prohibit and eliminate all corporal punishment. We hope that the UPR Process will give particular attention to states' response, or lack of response, to the concluding observations from treaty bodies, on this and other key issues.

In June 2006, the Committee on the Rights of the Child adopted General Comment No. 8 on "The right of the child to protection from corporal punishment and other cruel or degrading forms of punishment", which emphasises the immediate obligation on states parties to prohibit all corporal punishment of children, including within the home. Other treaty bodies, and regional human rights mechanisms, have condemned all corporal punishment. In October 2006, the report of the UN Secretary General's Study on Violence against Children was submitted to the General Assembly. It recommends universal prohibition of all corporal punishment, setting a goal of 2009.

#### **Summary**

This briefing describes the legality of corporal punishment of children in <u>Chad</u>, despite the recommendations of the Committee on the Rights of the Child. We hope the Review will highlight with concern Chad's disregard for the Committee's recommendations, and strongly recommend that the government introduce legislation as a matter of urgency to prohibit corporal punishment of children in all settings, including the home.

## 1 Legality of corporal punishment in Chad

- 1.1 Corporal punishment of children is lawful in the **home**. Laws against violence and abuse, including the prohibition of cruel, inhuman or degrading treatment in Act No. 06/PR/2002, are not interpreted as prohibiting corporal punishment of children. In August 2007, a child protection law was being drafted but we have no further information.
- 1.2 There is no explicit prohibition of corporal punishment in **schools**.
- 1.3 In the **penal system**, corporal punishment is unlawful as a sentence for crime but is not explicitly prohibited as a disciplinary measure in penal institutions.
- 1.4 Corporal punishment is lawful in **alternative care settings**.

### 2 Recommendations by human rights treaty monitoring bodies

2.1 In 1999, following examination of the state party's initial report, the **Committee on the Rights of the Child** expressed concern about the use of corporal punishment in families, schools and other institutions, and recommended that the State party "review its policies and legislation to eliminate corporal punishment as a method of discipline" (CRC/C/15/Add.107, para. 25).
